145. Crash Description/Narrative

V2 was traveling northbound on Jack Martin Blvd. approaching the intersection of Quadara Blvd. V1 was directly behind V2.

Approximately 350 ft. north of Quadara Blvd., V2 slowed to make a left turn into the Ocean Medical Center parking lot. V2 came to a complete stop awaiting traffic before the left turn. V1 struck the rear of V2.

No injuries were reported on scene by either driver.

After further investigation, D1 was arrested for DUI. See arrest case form.

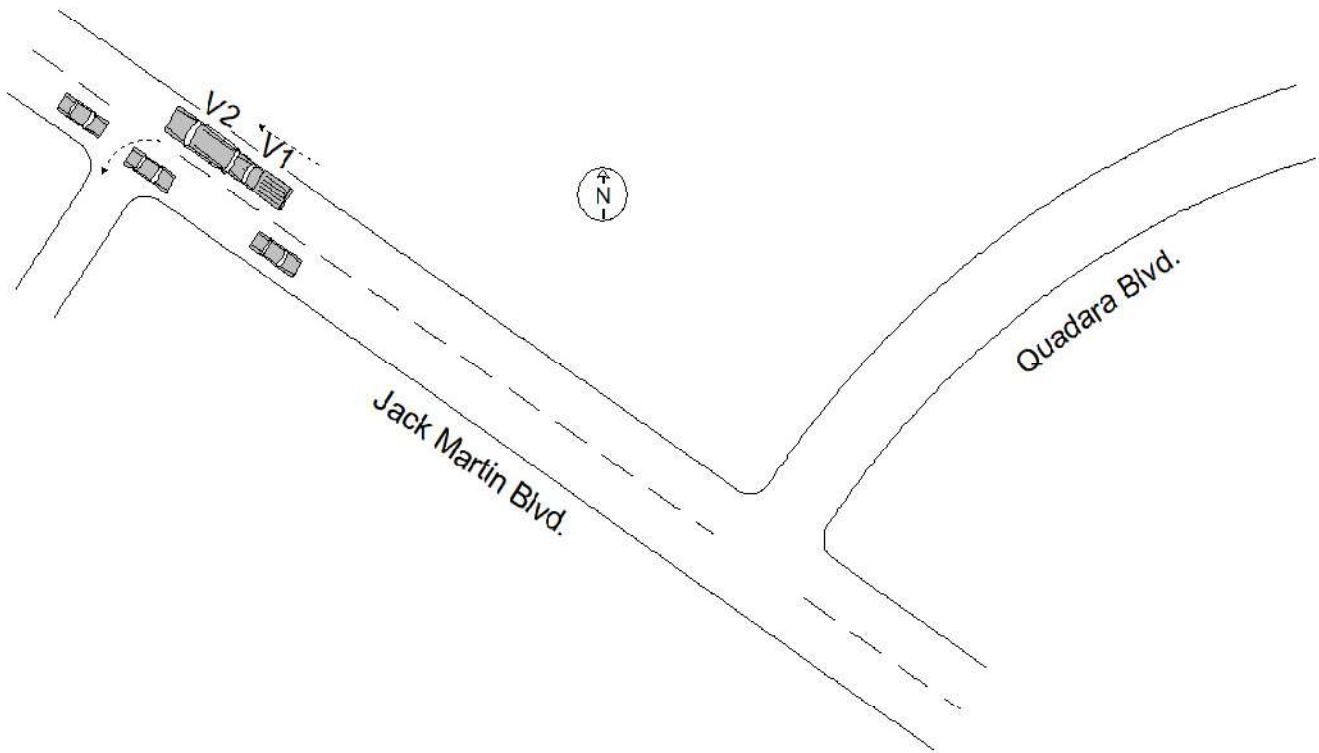
