145. Crash Description/Narrative

Vehicle 1 was attempting to park in a parking space located in Parking Lot C at Ocean Medical Center (425 Jack Martin Blvd.). Vehicle 1 struck parked occupied Vehicle 2 in the rear right bumper with its front left bumper.

Both vehicles received minor damage. Driver 1 provided vehicle insurance, driver license, and vehicle information to the vehicle owner of Vehicle 2. Driver 1 left the scene prior to police arrival. Pictures of information were provided by Vehicle 2 owner. Driver 1 could not be located by Lakewood Police at her residence.

Vehicle owner of Vehicle 2 stated she was inside her parked vehicle when it was struck. She further advised that after exchanging information she allowed Driver 1 to leave the scene while she waited for police arrival.

Based on Vehicle 2 owner's statement, I find Driver 1 at fault for improper parking.

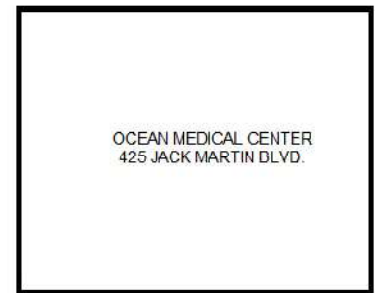
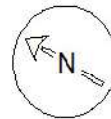
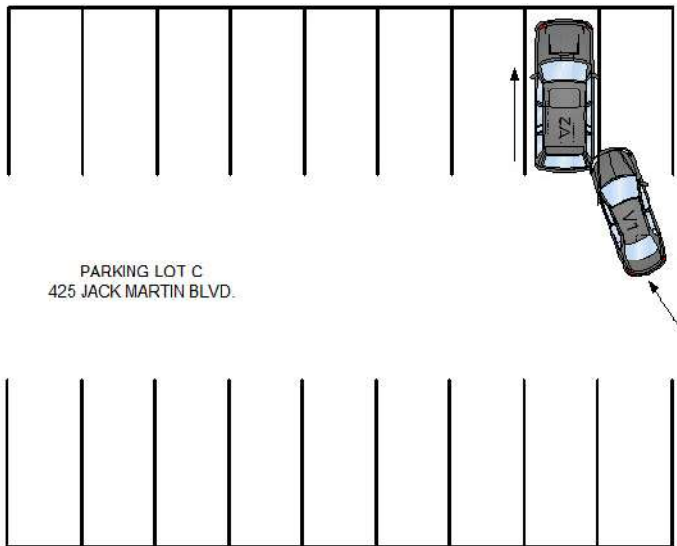
