145. Crash Description/Narrative

Investigation revealed that vehicle #2 was parked on a downhill curve by driver #1/valet. Driver #1/valet then

took charge of vehicle #1 after receiving keys from the owner and placed it in park by the front entrance.

Vehicle #1 then rolled forward, un-occupied, and crashed into vehicle #2's left lower bumper with it's front

right bumper.

Driver #1/valet stated he just finished parking vehicle #2 when vehicle #1 pulled up requesting valet service. He

got into vehicle #1, pulled forward, and parked it directly in front of the entrance of the hospital. Driver

#1/valet stated seconds later he heard a crash and saw vehicle #1 up by vehicle #2. Driver #1/valet said he saw

that both vehicle's were damaged and he notified his supervisor and this agency.

The driver/valet works for Cypress Heath Care Valet Service of Hackensack Meridian Health.

Driver#1 was issued a summons #1506-E20-474 for 39:4-97

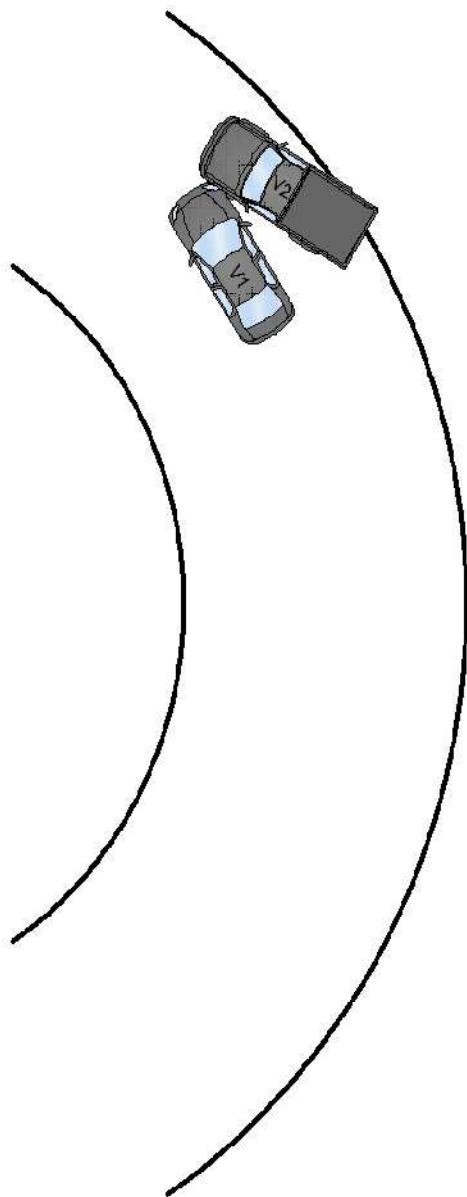

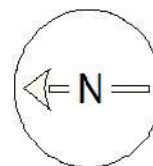
