145. Crash Description/Narrative

Vehicle #1 was reversing in front of Brick Hospital's emergency room entrance, located at 425 Jack Martin Blvd. and while backing, struck the front driver side of Vehicle #2 which was parked. Vehicle #2 was parked in front of the emergency room entrance of Brick hospital located at 425 Jack Martin Blvd. directly behind vehicle #1. No injuries were reported on scene.

Driver #1 stated she was backing up the Ocean Ride bus, to park it in front of the entrance of Brick Hospital and did not see vehicle #2 parked behind her.

Vehicle #2 was parked in front of the emergency entrance to Brick Hospital. No persons were inside the vehicle at the time. The owner of vehicle #2 stated he parked his vehicle there because he wife was having a baby.

My investigation revealed that Driver #1 was at fault for backing up unsafely and striking vehicle #2.

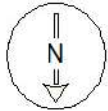

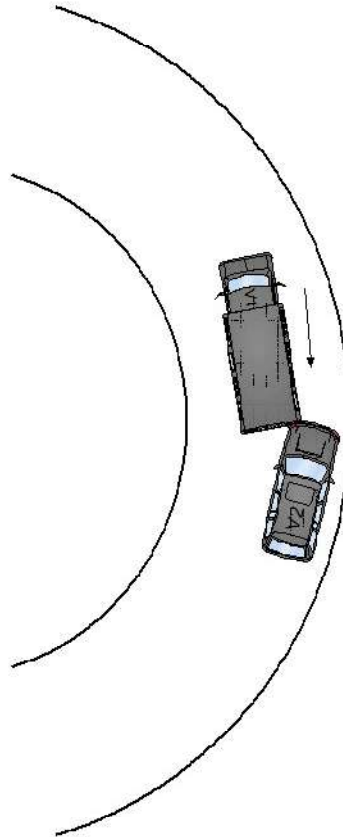

144 Crash Diagram (NOT TO SCALE)

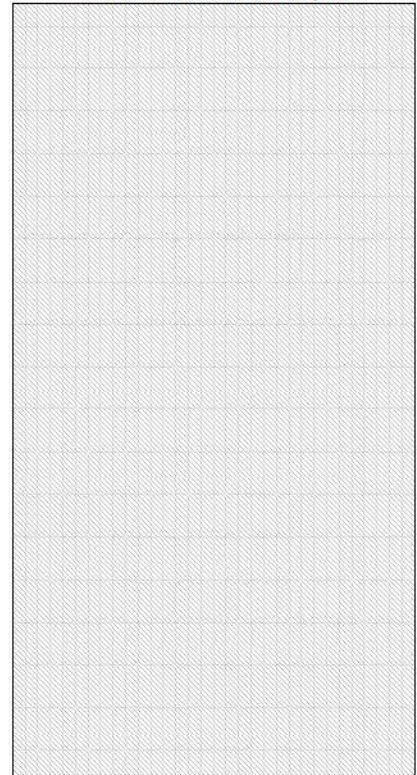
