145. Crash Description/Narrative

Vehicle#2 was traveling East on Route 70 in the right lane just prior to Jack Martin Blvd. Vehicle#1 was

traveling East on Route 70, next to Vehicle#2, on the shoulder. As Vehicle#1 approached the entrance to the

Walmart, 1872 Route 88, driver#2 turned right into the entrance. As Driver#2 began to turn right Driver#1 passed

him on the shoulder causing Vehicle#2 to strike Vehicle#1. Driver#2 admitted to passing on the shoulder.

Driver#2 stated that he never saw Vehicle#1 because it was passing on the shoulder. Driver#1 was determined to

be at fault. Vehicles were moved prior to arrival, both drivers refused first aid.

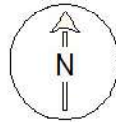

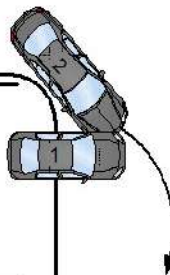
