145. Crash Description/Narrative

Investigation revealed that vehicle #1 was making a left turn onto Route 88 East, from Hospital Drive. Vehicle #1 was not supposed to make the left due to a posted sign signaling for a "Right turn only". Vehicle #2 was making a left turn from Route 88 onto hospital at the same time when vehicle #1 crashed into the back left lower bumper of vehicle #2 with it's front left lower bumper.

Driver of vehicle #2 stated as she was making a left turn on to Hospital Drive, vehicle #2 made the illegal left turn and crashed into her lower rear driver side bumper with it's driver side front bumper.

Driver of vehicle #1 stated she made the left turn onto Route 88 to go home because she was confused and new to the area. Driver of vehicle #1 knew she was not supposed to make the left turn, did it anyway and thought she was able to make it around vehicle #2 as it was making it's left turn into hospital drive. Driver of vehicle #1 said she then crashed into the back of vehicle #2 with her front bumper.

Driver of vehicle #1 was issued a summons for the following:

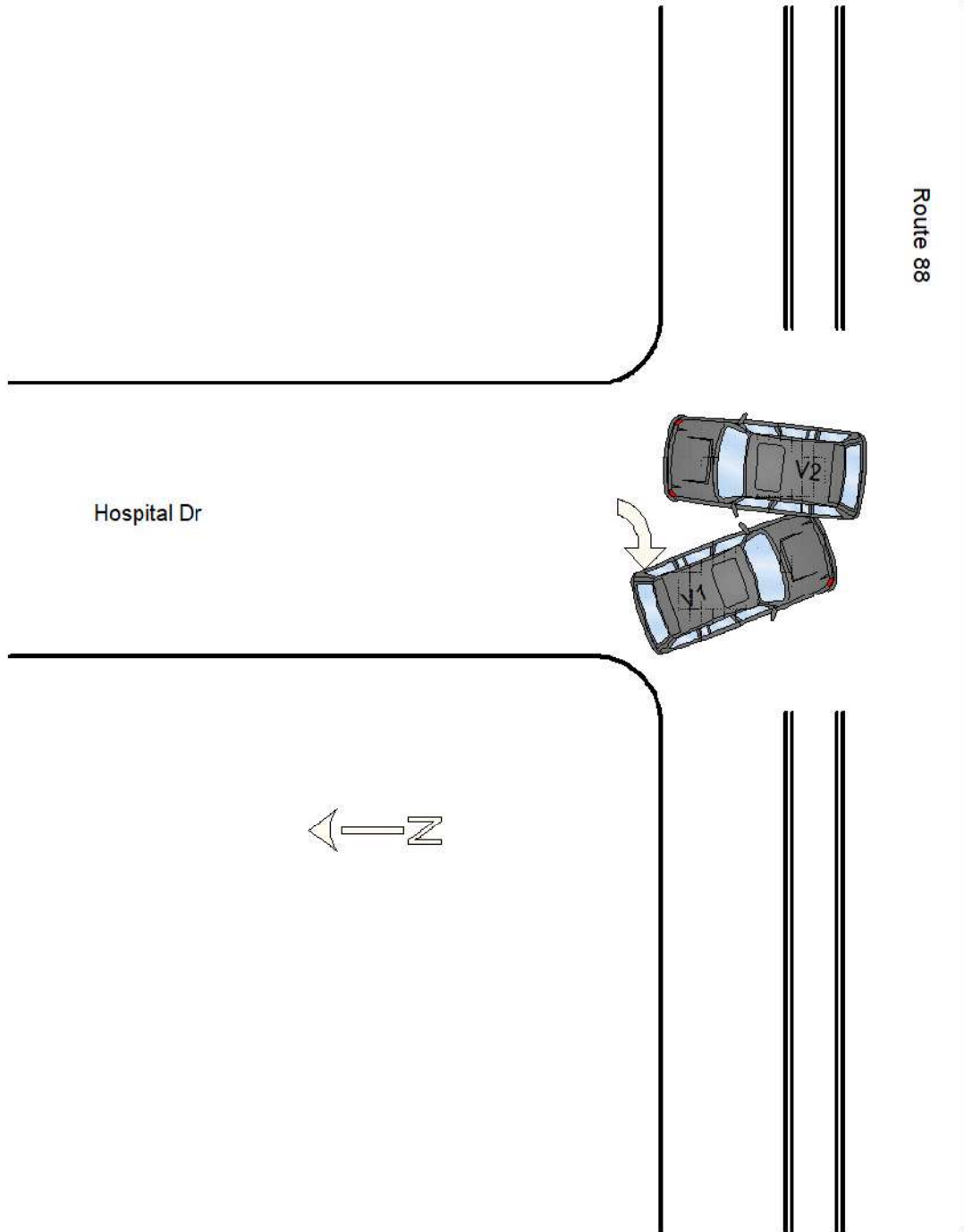
