145. Crash Description/Narrative

A motor vehicle crash occurred in the parking lot of Ocean Medical Center, 425 Jack Martin Blvd.

Driver #1 stated she was backing out of her parking space and did not see Vehicle #2 parked behind her. As she was backing, she struck the rear of Vehicle #2.

Vehicle #1 had minor damage to the rear driver's side of the vehicle. Ptl. Carter #280 responded out to the owner's residence and confirmed the damage.

Vehicle #2 was parked in a parking spot and unoccupied at the time of the crash. Vehicle #2 had a dent and paint transfer on the rear passenger side of the vehicle.

There were no reported injuries while on scene.

Driver #1 was attempting to back out of her parking space and struck Vehicle #2 which was parked in a parking space. Vehicle #1 is at fault for the crash for improper backing and driver inattention.

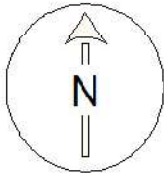

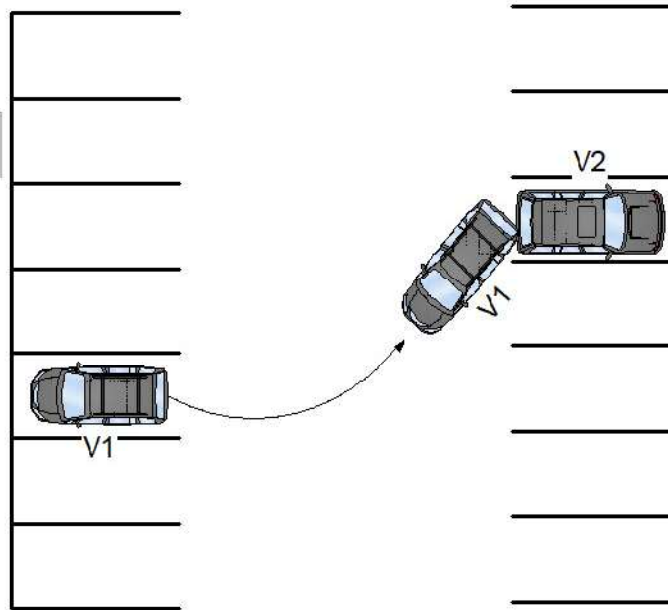
144 Crash Diagram (NOT TO SCALE)
