145. Crash Description/Narrative

Vehicle #1 was passing turning vehicles on the shoulder of Rt 88 east approximately 500 feet west of Van Zile Rd and crashed into the rear of Vehicle #2.

The driver of Vehicle #1 stated that he was passing a stopped large truck on the right shoulder. He explained that as he passed the truck, he did not see Vehicle #2 that was in front of it, making a left turn into the Laurel Square Plaza. He added that he crashed into the rear of Vehicle #2.

The driver of Vehicle #2 stated that she was waiting for traffic to clear so that she could make her left turn when Vehicle #1 crashed into her rear bumper.

No injuries were reported on scene.

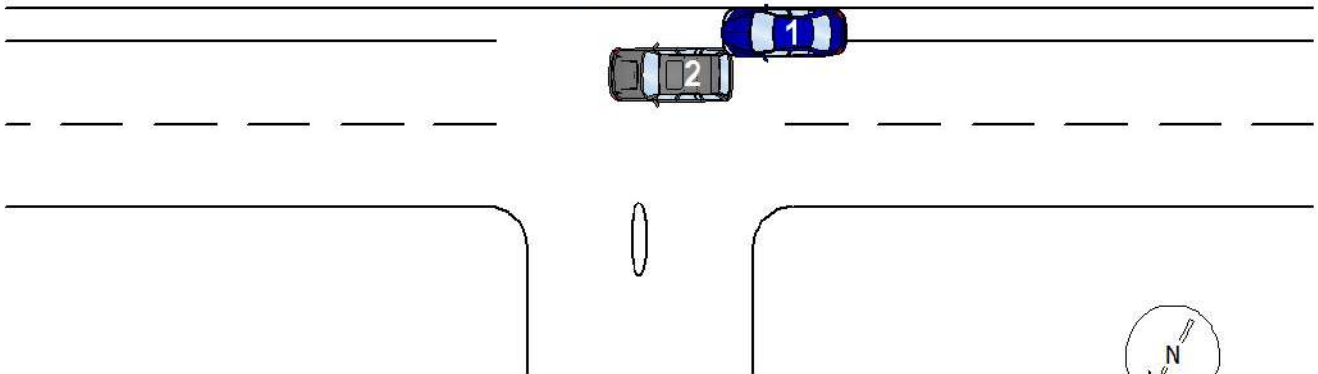
