145. Crash Description/Narrative

A motor vehicle crash occurred on Route 88 approximately 500 feet west of the intersection to Van Zile Road. The crash occurred in front of Laurel Square Shopping Center (1930 Route 88).

Driver of Vehicle #1 advised she was traveling east on Route 88 towards Van Zile Road. Driver #1 advised she was distracted by something and looked down or out her window. When she looked back at the road, she observed Vehicle #2 turning into Laurel Square. Driver #1 advised she struck the rear of Vehicle #2 and closed her eyes until her vehicle stopped. When she was stopped, she was in the grass area across from the Laurel Square entrance.

There was damage to the front driver side fender and the rear passenger tire was bent from Vehicle #1. Vehicle #1 was towed by Andrews Auto Body.

Driver of Vehicle #2 advised she was stopped with her left turn signal on to turn into Laurel Square. She began to turn left into Laurel Square when she was struck from behind by Vehicle #1. Driver #2 advised this caused her vehicle to spin and when she stopped, she pulled into Laurel Square to await the Police.

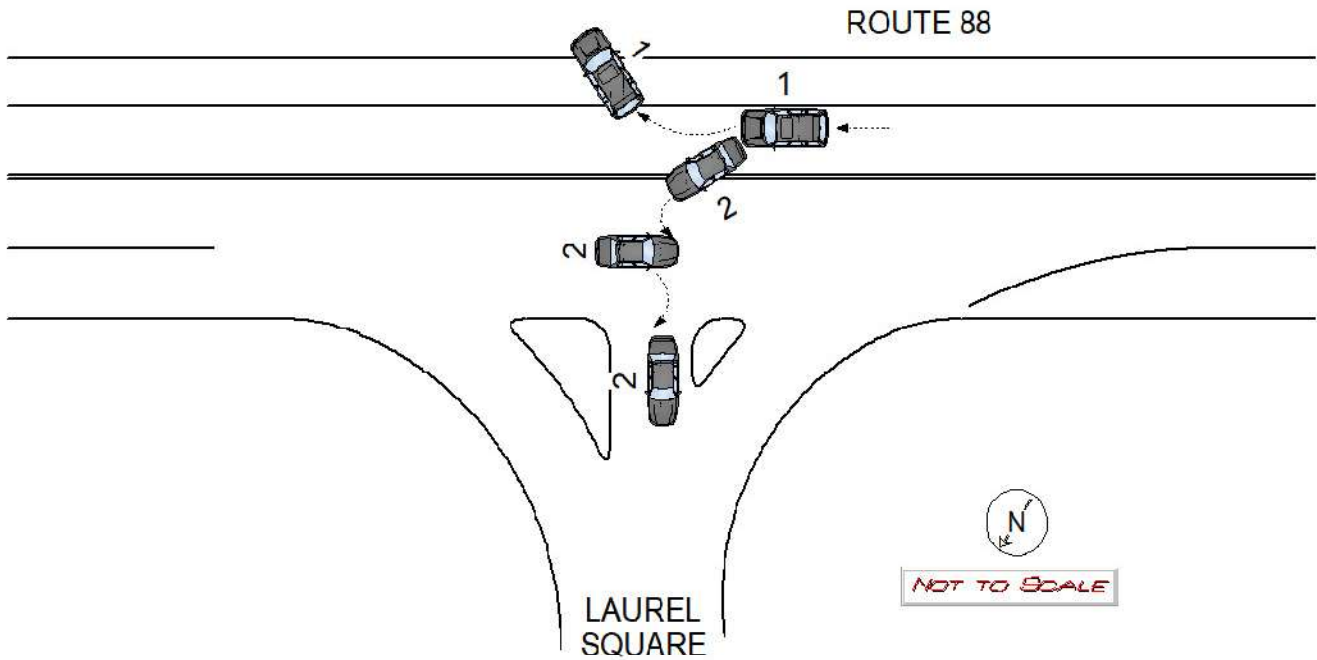
