145. Crash Description/Narrative

Vehicle 2 traveled westbound on Route 88 approximately 250 feet west of Van Zile Road near the exit for the parking lot of Laurel Square. Vehicle 1 made a left turn out of the parking lot of Laurel Square and impacted the rear passenger door of vehicle 2. Vehicle 1 left the scene eastbound on Route 88 immediately following the crash.

Driver 2 stated vehicle 1 exited the parking lot without coming to a stop and impacted the passenger side of her vehicle. Driver 2 described the suspect vehicle as a dark colored, small SUV, with a Santa attached to the grill. The pants from the Santa doll were lodged in the rear passenger wheel well of vehicle 2, no other description provided. No injuries were reported on scene. Vehicle 2 was able to be driven away from the scene. Based on this investigation, vehicle 1 was at fault.

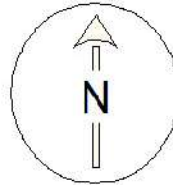

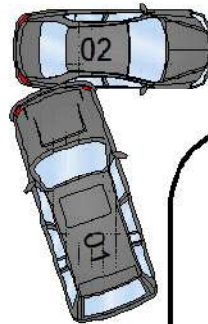
144 Crash Diagram (NOT TO SCALE)
