145. Crash Description/Narrative

Vehicle 1 was slowing in traffic on Route 88 in the area of Van Zile Road. Vehicle 2 was stopped in traffic on Route 88 in the area of Van Zile Road. Vehicle 1 failed to stop prior to striking the rear of Vehicle 2, causing the crash.

Driver 1 stated the following: he was traveling west on Route 88 in the area of Van Zile Road when he noticed Vehicle 2 was stopped in traffic. He attempted to brake, but accidentally used his previously injured left leg and could not generate enough pressure on the brake in order to stop the vehicle, prior to striking the rear of Vehicle 2.

Driver 2 stated the following: she was stopped in traffic on Route 88 in the area of Van Zile Road when she was rear ended by Vehicle 1.

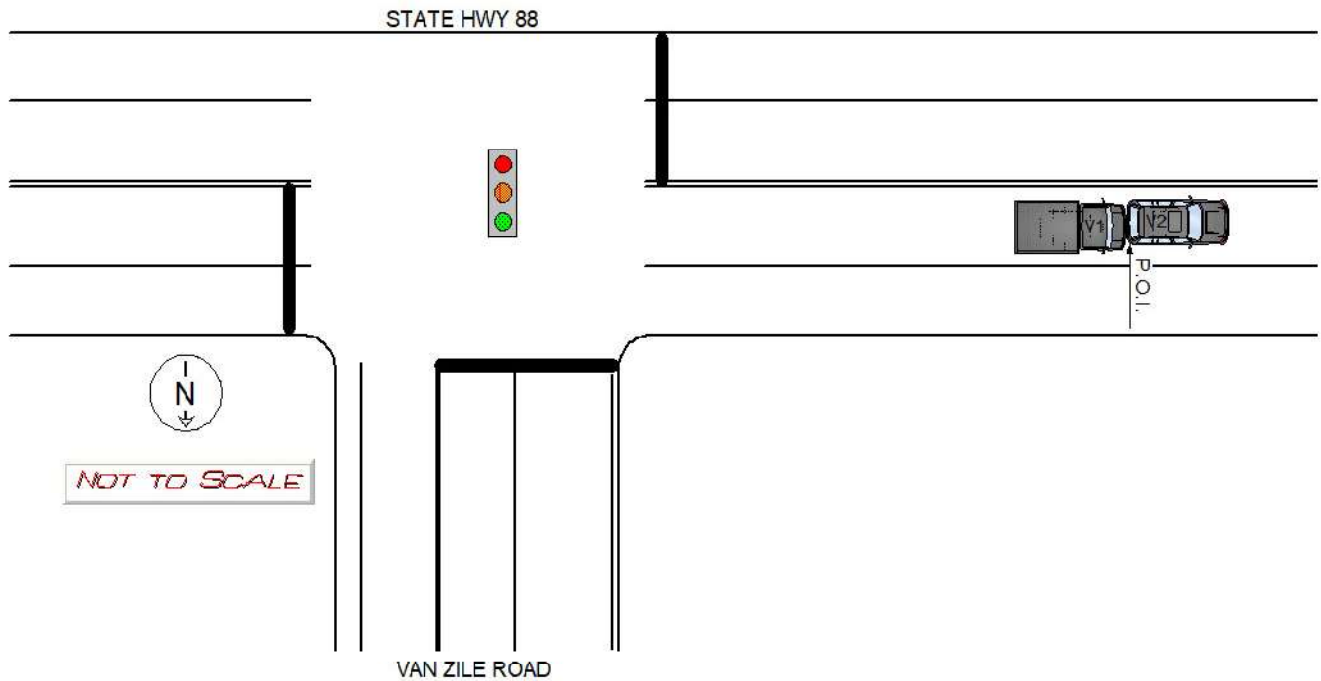
