145. Crash Description/Narrative

Vehicle #1 was slowing in traffic behind Vehicle #2 on Rt 88 E/B approximately 200 feet west of Van Zile Rd.

When Vehicle #2 came to a full stop, Vehicle #1 crashed into it's rear bumper.

The driver of Vehicle #1 stated he was not anticipating Vehicle #2 stopping so quickly and that he was unable to avoid crashing into it's rear bumper.

The driver of Vehicle #2 stated that she was stopping in traffic when Vehicle #1 crashed into her rear.

No injuries were reported on scene.

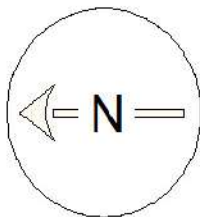
