145. Crash Description/Narrative

Vehicle 2 was east on Route 88 stopped in traffic waiting to make a left turn into the Laurel Square Shopping Plaza. Vehicle 1 was east on Route 88 directly behind vehicle 2. Vehicle 1 rear ended vehicle 2.

Driver 1 stated she was traveling east on Route 88 when she looked in the back seat to check on the child in the child seat. Driver 1 stated when she looked back is when she rear ended vehicle 2.

Driver 2 stated he was traveling east on Route 88 and stopped for traffic to wait to make a left turn into the Laurel Square Shopping Plaza. Driver 2 stated he was stopped with his left turn signal on when he was rear ended by vehicle 1.

Investigation revealed that the cause of the crash was due to driver 1 being distracted and looking into the back seat while driving.

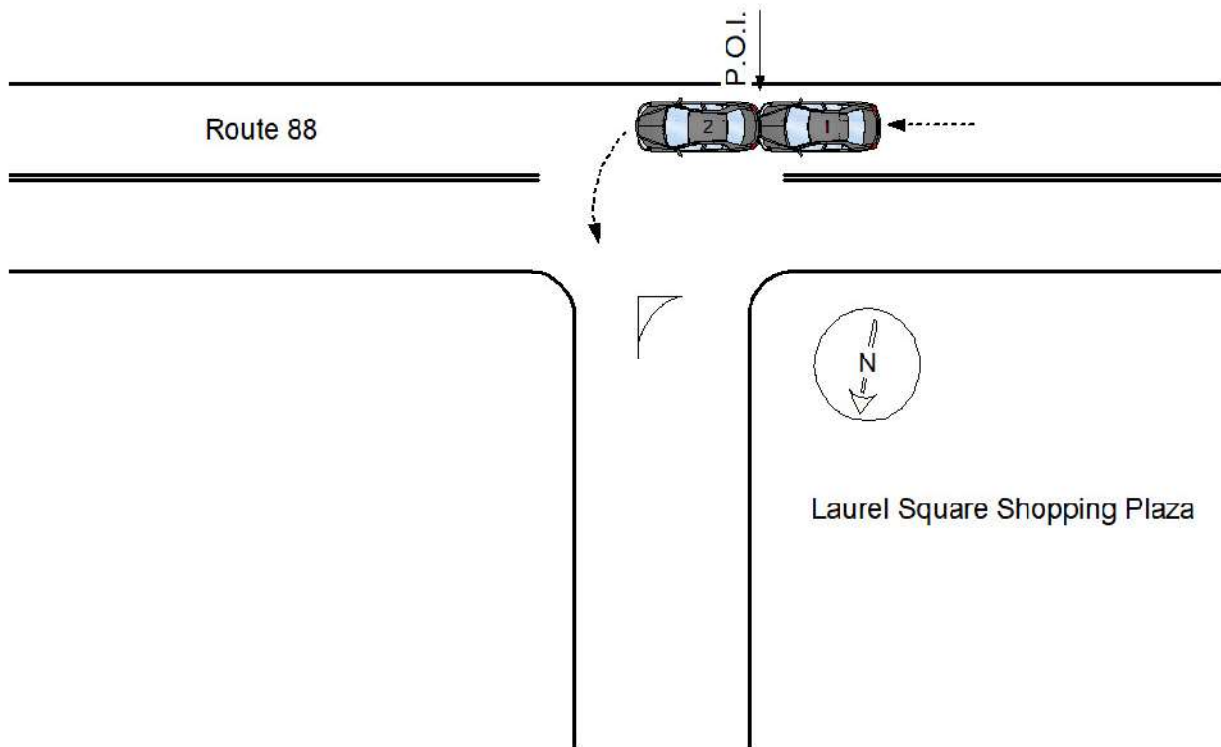
