145. Crash Description/Narrative

On 11/9/19 at approximately 1850 hours I responded to the Walmart Parking lot (1872 Rt. 88) to meet the caller of a Hit and Run. Dispatch advised the caller is in the Parking lot waiting near his vehicle which the caller stated was two Red Jeeps covered in mud. I made contact with a Vincent Camarato and Bryan Melillo (who was later identified). I observed two red Jeep's, one bearing the NJ registration B93-LDB and one bearing the NJ registration V66-LSZ. Camarato the driver of the red Jeep bearing the NJ registration B93-LDB stated he was the only one involved in the motor vehicle accident. Melillo who was operating the red Jeep bearing the NJ registration V66-LSZ stated he was not involved. (reference Case# 71037-19 for further information)

On 11/9/19, shortly after the last incident, Ptl. Shevchuk #294 and I responded to the area of Route 88 and Burrsville Road for a report of a hit and run. Upon our arrival we were met by Peter Howell who stated he was involved in a hit and run accident with two red Jeeps. Howell further advised he was traveling South on Burrsville Road at the intersection of Jack Martin Boulevard. Howell stated he was waiting for the light to turn green to continue South on Burrsville Road. Howell stated the light turned green and he proceeded South on Burrsville Road when he observed a Red Jeep(V#1) come from behind him and attempted to pass him on the right hand

side from the right lane. Howell stated he continued to merge into the lane of travel to continue South when he was struck by a red Jeep. Howell stated the Jeep continued South after striking his vehicle and Howell continued to follow the Jeep.

While Howell was following the Jeep(V#1) he was involved in a second accident with a second red Jeep (reference Case#71037-19 for further information).

Howell stated after getting into the second accident on Route 88 with the second red Jeep he was involved in a road rage incident (reference case number for the road rage/criminal mischief-71038-19). Howell further advised after the road rage incident both red Jeeps fled the scene. Howell remained on scene and contacted the police shortly after.

On 11/14/19 I was able to find contact information for Melillo (Driver of V#1). I called Melillo and left a message to contact me back when possible.

On 11/17/19 at approximately 1736 hours I responded to 693 Harbor Road (address listed on Melillo's license) to try and make contact in reference to the accident. Upon my arrival, I was met by Bryan Melillo who stated he was not involved in any motor vehicle accident and did not make contact with Howell's vehicle. Parked in front of Melillo's residence, I observed the red Jeep Melillo was operating at the time of the incident bearing the NJ registration V66-LSZ. I did not observe any damage consistent with the damage on Howell's vehicle. It should be noted the wheel's stick out further than the wheel wells of the vehicle. I did not observe any damage on the vehicle's wheels or rims.

Due to the inconsistency of damage on V#1, conflicting statement's and lack of witnesses of this accident I am unable to determine who is at fault for the motor vehicle crash

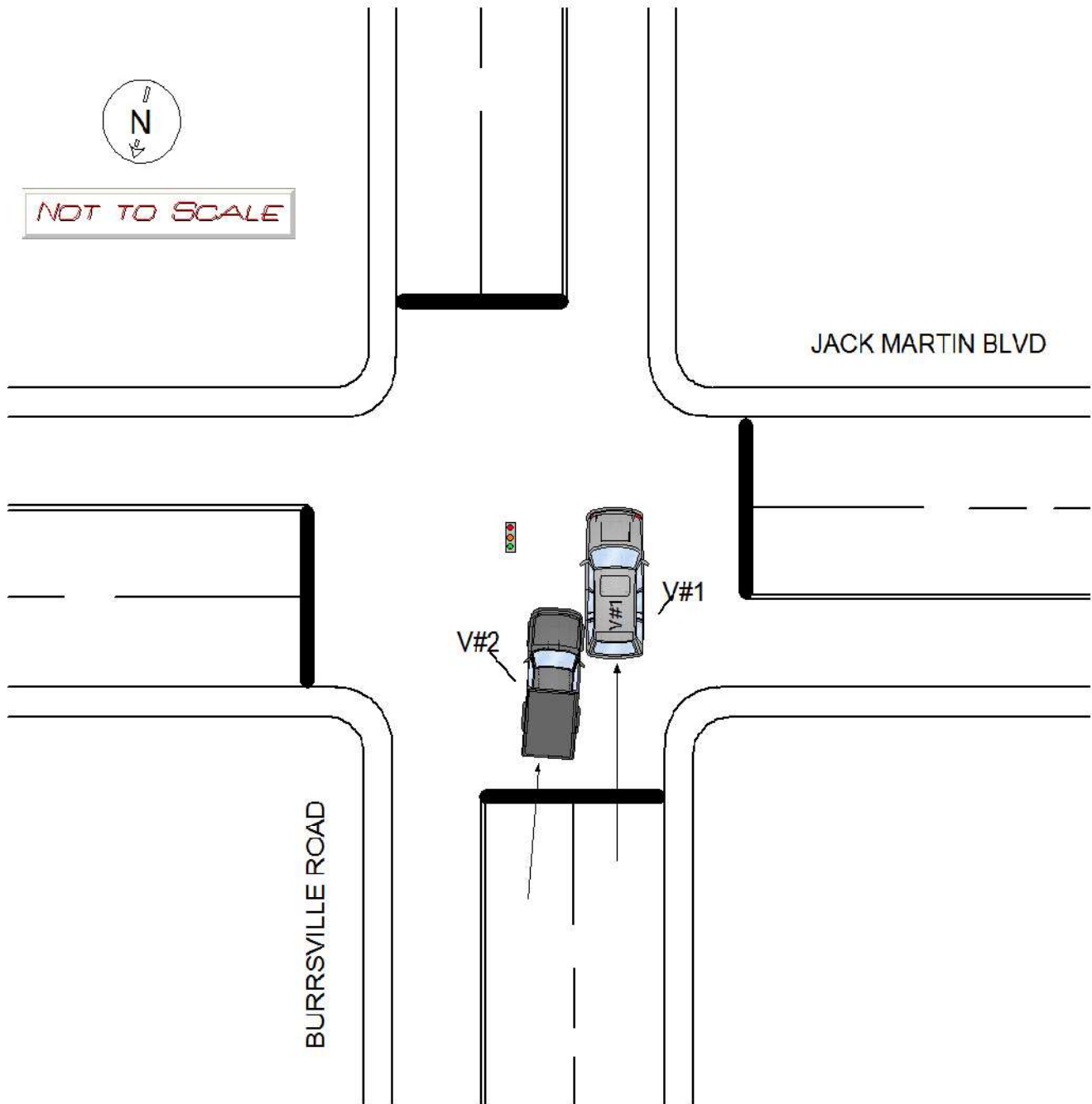
