145. Crash Description/Narrative

Investigation at the scene revealed: Vehicle 1 was exiting the parking lot of 224 Jack Martin Blvd., and was attempting to make a left turn onto Jack Martin Blvd. south bound. Vehicle 2 was traveling north on Jack Martin Blvd. and was approaching vehicle 1. Vehicle 1 initiated the left turn in close proximity of vehicle 2. Vehicle 1 did not clear the north bound lane in time, which caused the left front of vehicle 2 to collide with the left rear of vehicle 1.

The driver of vehicle 1 stated she was attempting to exit the parking lot but there was heavy traffic on Jack Martin Blvd. The driver stated there was a gap in north bound traffic, and a south bound vehicle stopped to let her in. The driver stated she did not look north bound again to see if traffic had resumed, and pulled out. As she was crossing the north bound lane, she was struck by vehicle 2.

The driver of vehicle 2 stated he was traveling north on Jack Martin Blvd. when vehicle 1 pulled out in front of him. The driver stated he attempted to stop, but there was no time.

No injuries were reported at this time, and both vehicles were moved prior to my arrival.

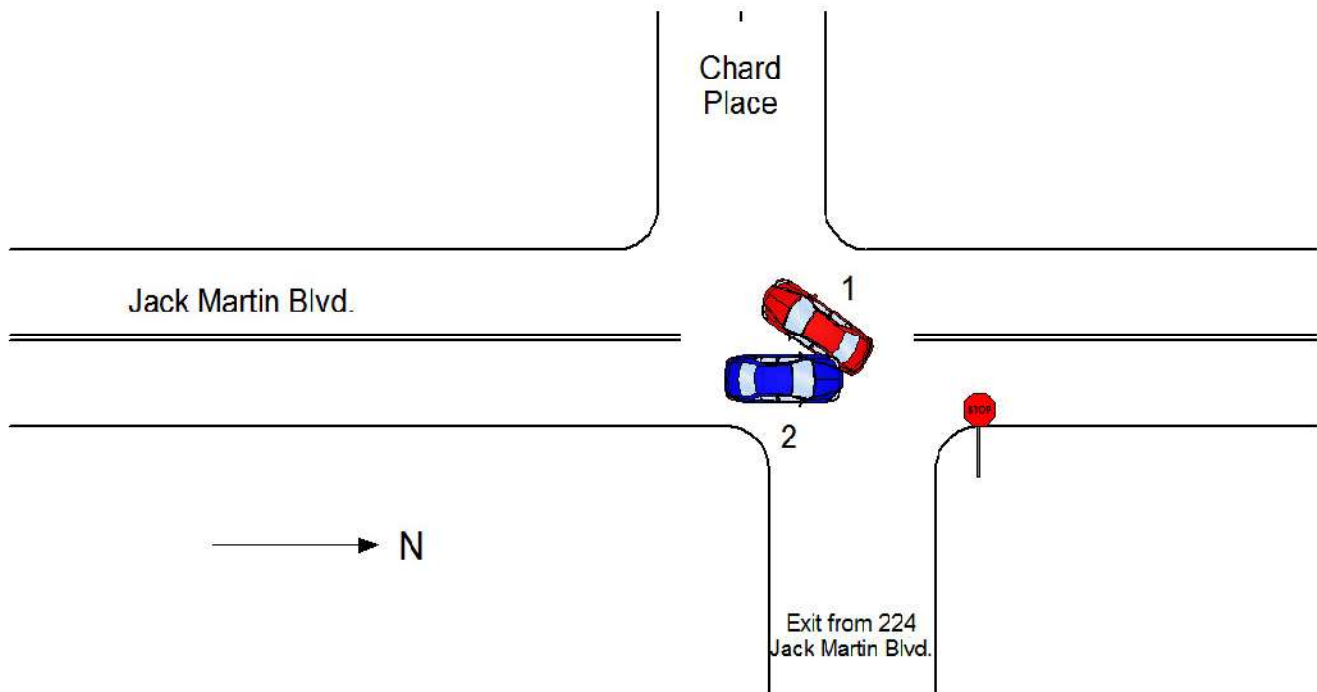
