145. Crash Description/Narrative

Vehicle 1 was traveling south on Burrsville Road directly behind vehicle 2, just north of the intersection of Jack Martin Boulevard. Vehicle 2 stopped in traffic and vehicle 1 failed to stop in time, rear ending vehicle 2.

Driver 1 stated he was traveling south on Burrsville Road approaching the intersection of Jack Martin Boulevard and he was directly behind vehicle 2. Driver 1 stated that traffic ahead had stopped and he was unable to stop in time, rear ending vehicle 2.

Driver 2 stated she was traveling south on Burrsville Road and she stopped in traffic just prior to the intersection of Jack Martin Boulevard. Driver 2 stated that while she was stopped in traffic vehicle 1 rear ended her.

Investigation revealed that the cause of the crash was due to driver 1 following too closely behind vehicle 2, as he did not have enough time or distance to stop safely when traffic ahead stopped.

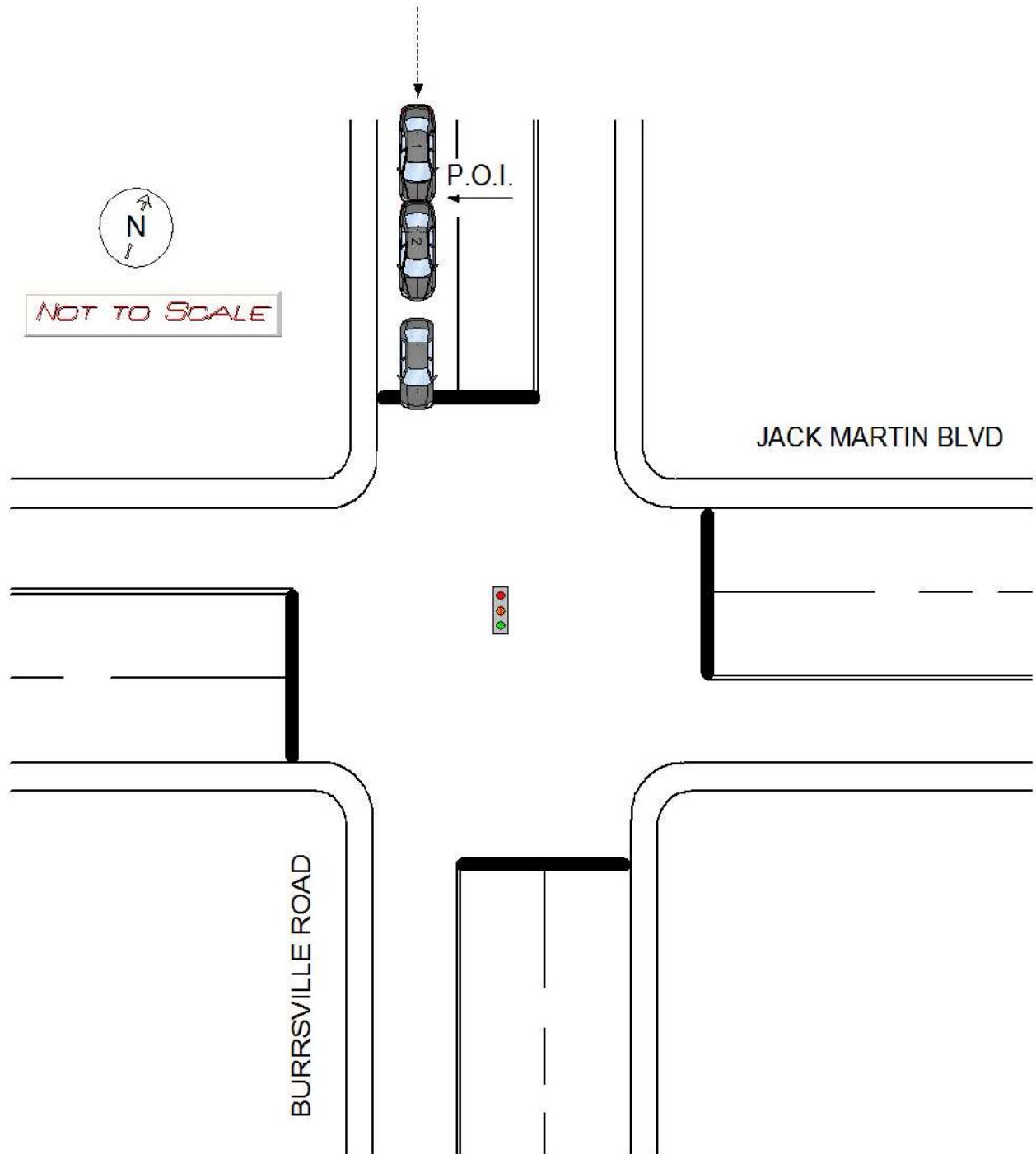
