145. Crash Description/Narrative

Vehicle #1 was traveling eastbound on Route 88 just passed the intersection of Younger Street. Vehicle #2 was traveling directly behind Vehicle #1.

Driver #1 stated she stopped to yield to the on-coming traffic in an attempt to make a left hand turn into the Walmart parking lot. She said she was stopped for approximately 15 seconds before she was struck from behind by Vehicle #1.

Driver #2 stated he was driving behind Vehicle #1 when it began to stop quickly. He tried to stop his vehicle as quick as he could but the front of his vehicle struck the front of rear of Vehicle #1.

Based on the statements made by both drivers and statements made by both drivers, I determined Vehicle #2 to be at fault for the crash.

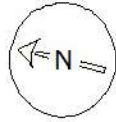
