145. Crash Description/Narrative

Investigation at the scene revealed: Vehicle 1 was traveling west on Rt.70 in the left lane, and was stopped in heavy traffic in the intersection of Olden St. Vehicle 2 was traveling west on Rt.70 in the center lane, and was stopped in heavy traffic in the intersection of Olden St. Vehicle 1 did not see vehicle 2, and attempted to change into the center lane. This caused the front right of vehicle 1 to collide with the left middle of vehicle 2.

The driver of vehicle 1 stated she was stopped in the intersection in heavy traffic, when the traffic signal cycled to amber. The driver stated she became nervous, and attempted to change into the middle lane to get out of the intersection, but did not see vehicle 2. While changing lanes, the right front of vehicle 1 struck the left middle of vehicle 2.

The driver of vehicle 2 stated she was stopped in heavy traffic in the intersection, when the right front of vehicle 1 struck the left middle of vehicle 2.

No injuries were reported at this time, and both vehicles were moved prior to my arrival.

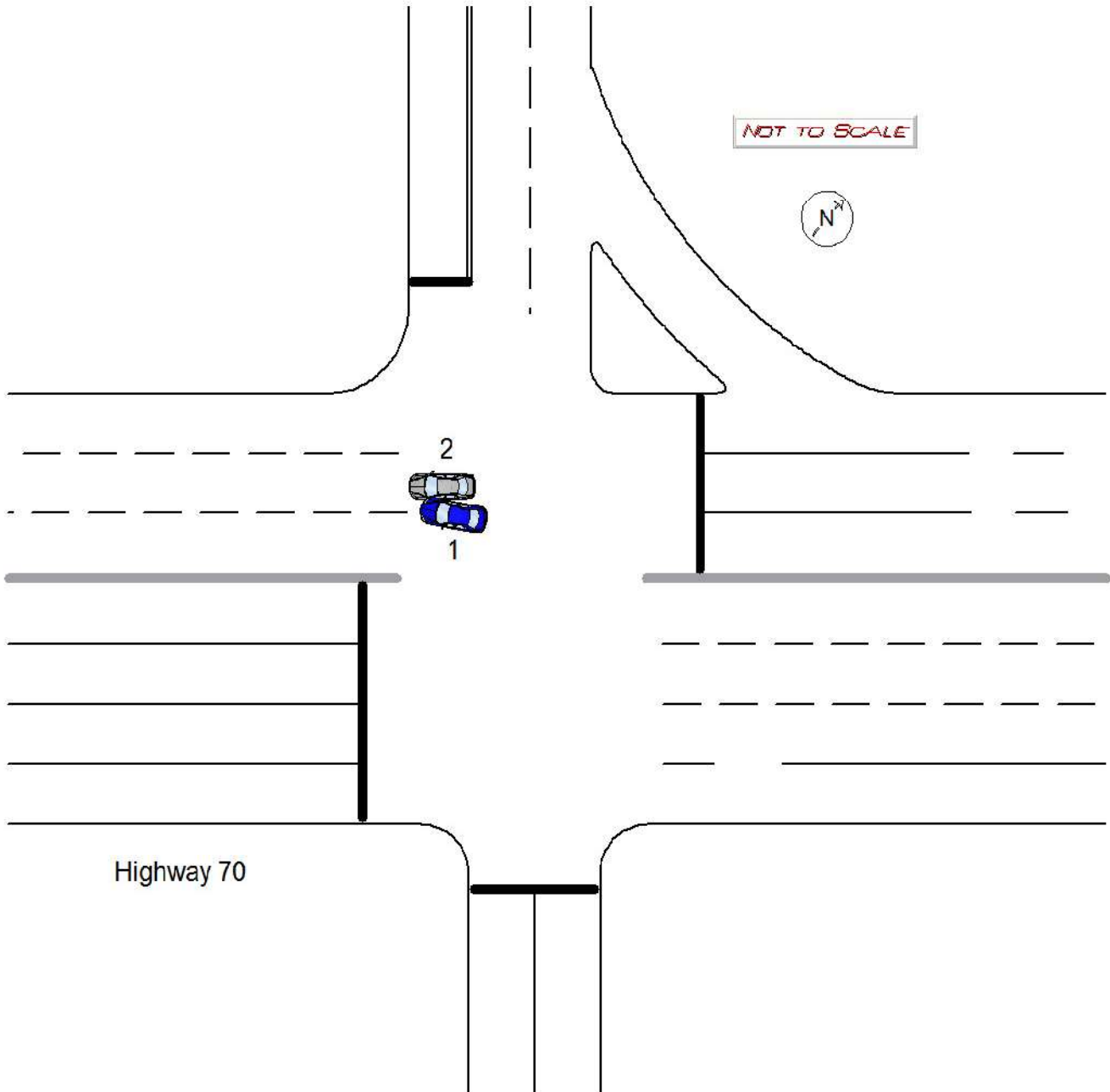
