145. Crash Description/Narrative

The driver of vehicle 1 advised he was traveling south bound on Jack Martin Blvd in the area of Frank Neri Dr. when traffic stopped short in front of his vehicle. The driver attempted to stop however was unable to in time, causing the front of his vehicle to collide with the rear of vehicle 2.

The driver of vehicle 2 advised she was stopped in traffic on Jack Martin Blvd when the driver of vehicle 1 collided with the rear of her vehicle. The impact of the crash caused her vehicle to move forward and then collide with the rear of vehicle 3, which was stopped in traffic in front of her vehicle.

The driver of vehicle 3 advised he was stopped in traffic on Jack Martin Blvd when vehicle 2 collided with the rear of his vehicle.

There were no reported injuries at the time of this report. Vehicle 1 sustained damage to the front, vehicle 2 sustained damage to the rear and front and vehicle 3 sustained damage to the rear.

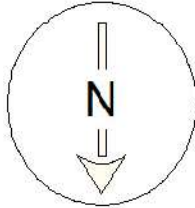

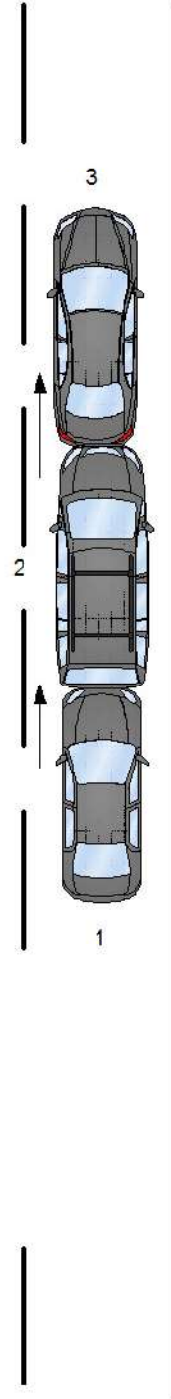
