145. Crash Description/Narrative

Crash investigation reveals a two vehicle, same direction (rear-end) crash. Vehicle 1 was traveling directly

behind vehicle 2 in the left lane on Route 70 W approaching the intersection of Route 70 W/Olden Street. As both

vehicles approached said intersection, the driver of vehicle 1 stated the traffic signal at Route 70 W/Olden

Street and turned amber at which time he observed vehicle 2 quickly come to a stop due to a vehicle that had

quickly stopped in front of vehicle 2.

The driver of vehicle 1 stated he saw vehicle 2 quickly stopping and quickly stepped on his brake pedal to stop.

The driver of vehicle 1 stated his vehicle was unable to stop which caused the front end of vehicle 1 to crash

into the rear of vehicle 2. No injuries were reported and both vehicles sustained minor damage. Both vehicles

were driven from the scene. The driver of vehicle 1 is at fault for the crash.
