145. Crash Description/Narrative

Vehicle #1 was traveling East on Jack Martin Blvd in the area of Burrsville Rd in the right lane. Vehicle #2 was traveling west on Jack Martin Blvd in the left lane. As Vehicle #1 was traveling through the intersection the trailer that Vehicle#1 was towing, Trailer#1, became unhitched and struck Vehicle #2. After striking Vehicle#2, Trailer#1 continued to travel across Jack Martin Blvd. (East) went up onto the embankment where it came to final rest.

Driver #1 stated as he was driving over the intersection his trailer came unhitched and struck Vehicle #2. Driver of vehicle #2 stated he was traveling West on Jack Martin Blvd. when he saw the trailer become unhitched and struck his vehicle. Trailer#1's safety chains were never attached to Vehicle#1 which caused Trailer #1 to travel freely after becoming dislodged from Vehicle #1's ball hitch.

At the conclusion of our investigation Vehicle #1 was deemed at fault for not securing the trailer properly.

Drivers and occupants refused first-aid. Vehicles were moved prior to arrival. Trailer was not.

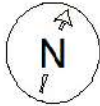

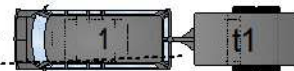
