145. Crash Description/Narrative

Vehicle #02 was traveling north on Jack Martin Blvd and approaching the area of 430 Jack Martin Blvd. Vehicle #01 was pulling out of the driveway from 430 Jack Martin Blvd and attempting to make a right turn onto Jack Martin Blvd, northbound. As vehicle #02 approached the area, vehicle #01 pulled out directly in front of vehicle #02 causing the front bumper of vehicle #02 to strike the driver side front quarter panel.

Driver of vehicle #02 stated as she was traveling north on Jack Martin Blvd, vehicle #01 pulled out directly in front of her and she could not avoid a collision. Driver of vehicle #01 stated as she was attempting to make a right turn onto Jack Martin Blvd, she became blinded by the sun glare and did not see vehicle #02 approaching as she proceeded forward.

Neither vehicles were not moved prior to police arrival. Driver of vehicle #01 had complaint of pain to her face/head and right leg. Driver of vehicle #02 sustained a bloody nose, laceration to her lip, complaint of pain to her left thumb and complaint of pain to her back. Brick Police EMS arrived on scene but both parties refused medical attention.

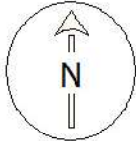

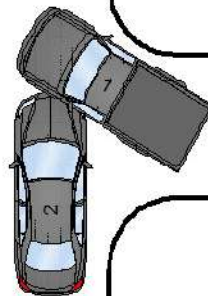
