145. Crash Description/Narrative

Vehicle #1 was traveling northbound in Camp Mall, 1905 Rt. 88, parking lot. While driver #1 was attempting to exit the parking lot onto Rt. 88 eastbound, vehicle #1 collided with a utility pole guide wire support. The guide wire was attached to an unmarked Jersey Central Power & Light pole. The closest marked utility pole was JC228BK. Driver #1 stated when she was exiting the parking lot a pick up truck was waiting to make a left onto Rt. 88. She then attempted to go around the truck and struck the guide wire support. Driver #1 was found at fault for the accident.

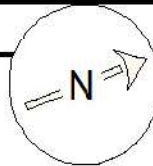

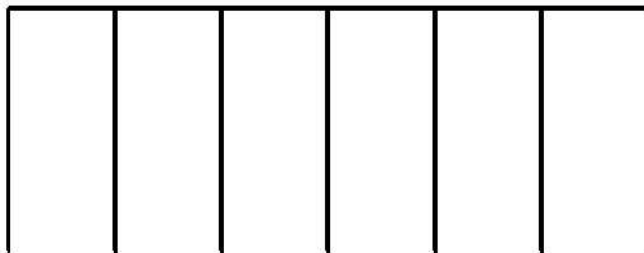

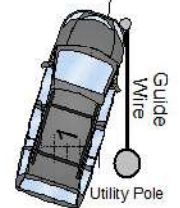
