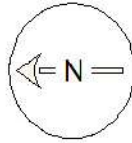

Motor Vehicle Crash Diagram

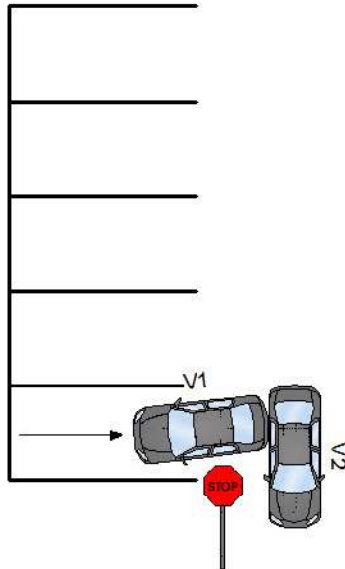
