145. Crash Description/Narrative

At the stop sign Burrsville Rd. and Rt 88 Vehicle 01 struck the rear of

Vehicle 02.

Driver of Vehicle 01 stated she was stopped on Burrsville Rd south behind Vehicle 02 at the stop sign of Rt 88.

Driver 01 stated she was then looking at traffic to her right and started to move forward striking the rear of

Vehicle 02. Driver of Vehicle 01 stated she thought Vehicle 02 had already started in traffic.

Driver of Vehicle 02 stated she was stopped on Burrsville Rd. south at the stop sign for Rt 88 when she was

struck in the rear by the front of Vehicle 01 which was directly behind her.

Both Vehicles moved prior to police arrival.

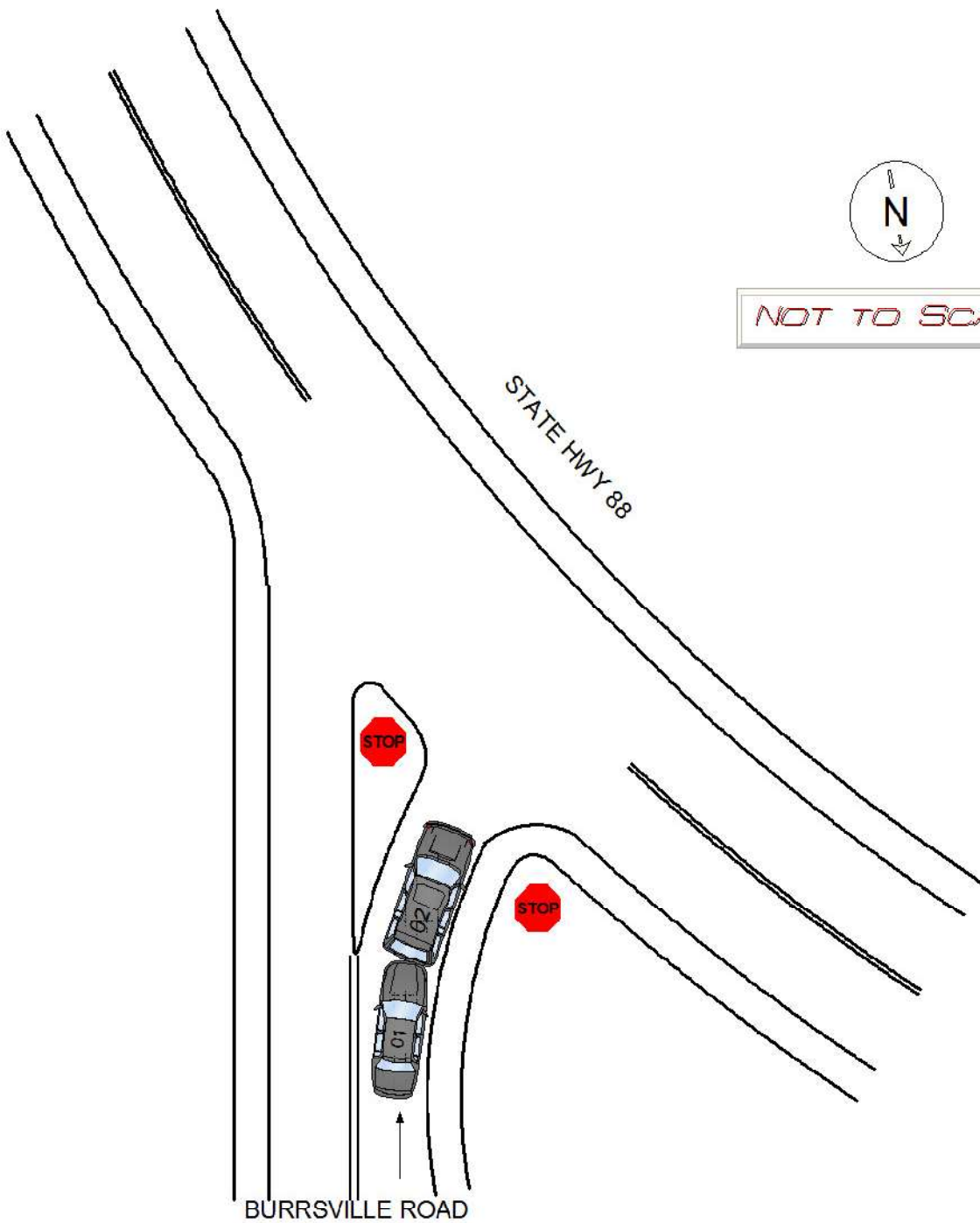
