145. Crash Description/Narrative

Vehicle 1 was traveling east on Route 88 directly behind vehicle 2. Vehicle 2 slowed down to turn left into the parking lot of 1608 Route 88 when vehicle 1 rear ended vehicle 2.

Driver 1 stated she was traveling east on Route 88 directly behind vehicle 2 when vehicle 2 unexpectedly slowed to turn left into the parking lot of 1608 Route 88. Driver 1 stated she did not see vehicle 2's turn signal and was unaware she was going to be turning left. Driver 1 stated that when vehicle 2 slowed down to turn she was unable to stop in time, subsequently rear ending vehicle 2.

Driver 2 stated that she was traveling east on Route 88 and that she turned on her left turn signal to turn into the parking lot of 1608 Route 88. Driver 2 stated she slowed down to turn into the parking lot when vehicle 1 rear ended her.

Investigation revealed that the cause of the crash was due to driver 1 following too closely behind vehicle 2, causing her to not have enough time to react when vehicle 2 slowed to make a left turn.

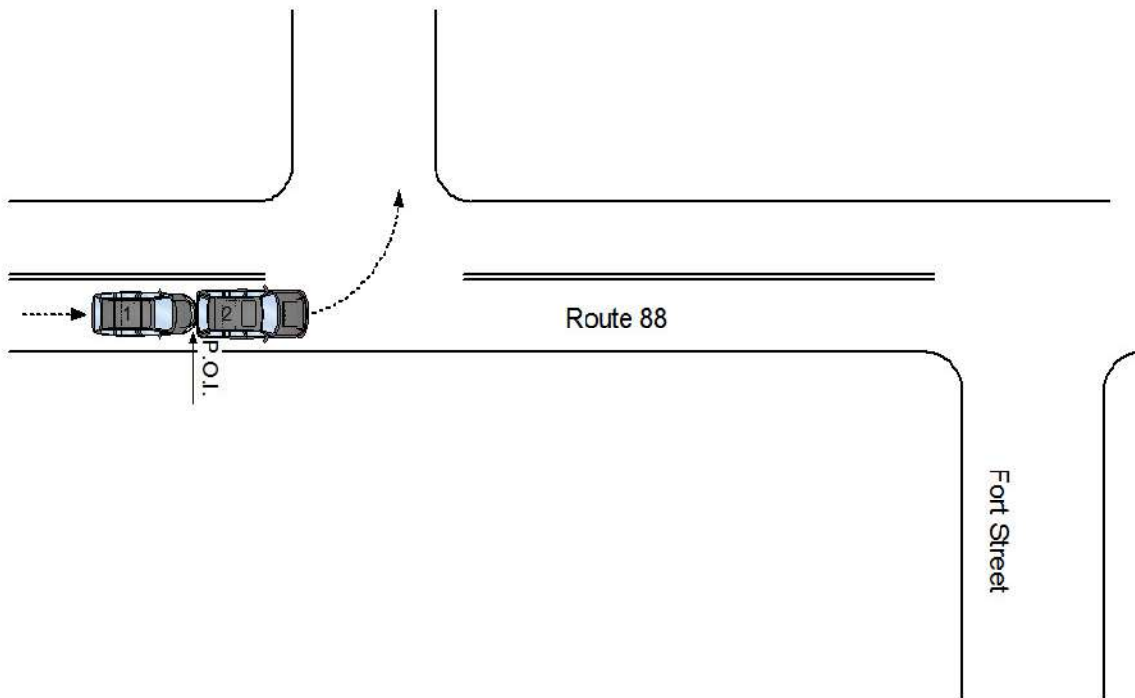
