145. Crash Description/Narrative

Vehicle #1 was parked in a marked parking space. Vehicle #2 was attempting to park in the spot directly to the right of Vehicle #1.

Driver #1 stated she was sitting in her car gathering her coupons before she went into the store when Vehicle #2 struck the passenger side of her car causing damage to both passenger side doors.

Driver #2 stated he was driving across the front of the store when he observed the first parking spot open so he began to make a 180 degree turn into the spot. While making the turn, the left front part of his bumper struck the passenger side of Vehicle #1 as he pulled into the spot.

Based on my observations and statements made by both drivers, I determined Vehicle #2 to be at fault for the crash.

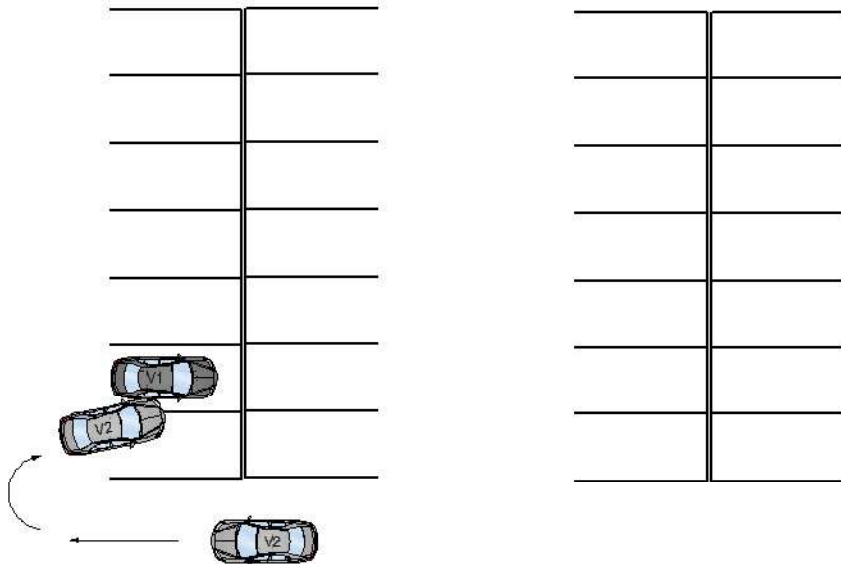
