145. Crash Description/Narrative

Vehicle 1 was backing out of a parking space in the parking lot of 1872 Rt. 88 when it struck vehicle 2 who was

stopped in traffic. Driver 1 stated that as he was backing out of the parking space, he did not see vehicle 2

stopped behind him prior to the collision. Driver 2 stated that she was stopped because of cars stopped in front

of her when vehicle 1 backed out of the parking space and collided with her driver side door. No injuries were

reported and minor damage was observed to both vehicles. The subsequent investigation found driver 1 to be at

fault for the crash as he failed to ensure there were no vehicles behind him before backing out of the parking

space.

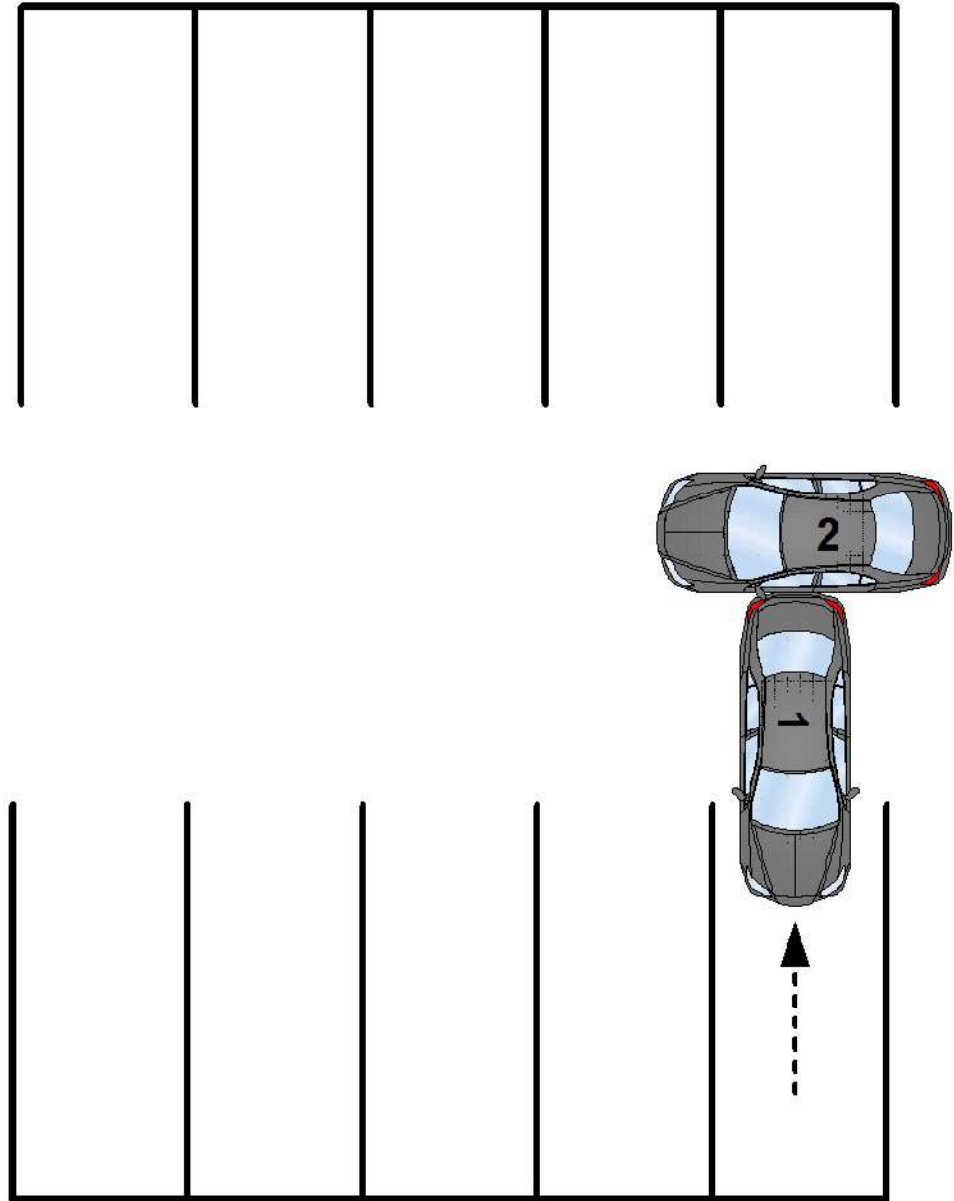
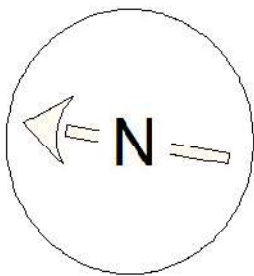
