145. Crash Description/Narrative

Vehicle 2 stopped in traffic on Route 88 westbound, just prior to Jack Martin Boulevard. Vehicle 1 traveling on Route 88 westbound, directly behind Vehicle 2.

Driver 2 stated she was stopped in traffic for an unknown amount of time when she felt the impact of Vehicle 1 striking the rear of her vehicle. Driver 2 found minor damage to the rear of her vehicle and stated she and her child were ok.

Driver 1 stated she was in traffic on Route 88 westbound that was "stop and go". Driver 1 stated at one point traffic had started to go again and she did not realize Vehicle 2 had stopped again. Driver 1 stated she was attempting to stop and slid on the wet pavement prior to striking the rear of Vehicle 2. Driver 1 stated her vehicle had previous front end damage and did not believe her vehicle had been damaged by the crash.

Driver 1 was found to be at fault for following too closely and failing to see Vehicle 2 stopped in front of her.

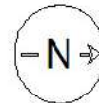

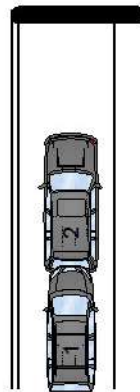
