145. Crash Description/Narrative

On 11/9/19 at approximately 1850 hours, I (Ptl. Marmer #304) responded to the Walmart (1872 NJ-88) for a report of

a Hit and Run. Dispatch advised the caller was in a Jeep that was covered in mud.

Upon my arrival, I observed a Red Jeep Cherokee bearing the New Jersey registration of B93-LDB. I also observed a

second Red Jeep parked next to the other vehicle Bearing the New Jersey registration V66-LSZ. I made contact

with the owner of the Jeep bearing the NJ registration B93-LDB, who was later identified as Vincent Camarato.

Camarato stated he was involved in a motor vehicle accident that happened approximately twenty minutes prior to

my arrival. He further advised the accident occurred on Route 88 East Bound between Laurelton Street and Allaire

Avenue. Camarato stated he then drove to the Walmart when his friend called to report the accident. Camarato

stated his friend and himself were driving south in two separate vehicle's traveling East on Route 88. Camarato

stated he was behind V#2 and advised V#2 began to apply his brakes. Camarato stated he attempted to avoid a crash

with V#2 and crossed over into the oncoming traffic lane to get around V#2. Camarato stated once he got around

the vehicle, V#2 struck the passenger rear side of his vehicle and rode over his tire. Camarato stated the driver

of V#2 exited his vehicle with a metal walking cane and threatened him.

Dispatch advised they received a second call in reference to the accident and stated the driver of V#2 was on scene of where the accident occurred. Ptl Shevchuk #294 and I responded to the area of Route 88 and Burrsville Road.

Upon our arrival, we were met by the driver of V#2 who was identified as Peter Howell. Howell stated he was in a motor vehicle accident that stemmed from a road-rage incident. Howell stated he was driving South on Burrsville Road when he approached the light at the intersection of Burrsville Road and Jack Martin. Howell stated he was in the left lane waiting for the light to change to continue South on Burrsville Road. Howell stated a red Jeep went in the right lane to try to get around him. Howell stated when the light turned green he began travel and the red Jeep tried to get around him. Howell advised the red Jeep struck his vehicle while attempting to pass him. He stated the red Jeep continued straight on Burrsville and he followed the red Jeep towards the intersection of Burrsville Road and Route 88. Howell advised they turned onto Route 88. Howell stated there was a second red Jeep that was behind him (V#1). Howell stated the vehicle that was behind him went into oncoming traffic and attempted to pass his vehicle. Howell stated the driver cut back into the Eastbound lane and attempted to run him off the road and struck his vehicle. Howell stated the driver's of both vehicles exited their vehicles and began to approach him. Howell advised the driver of V#1 approached Howell's vehicle and hit his driver's side mirror (Case number for the criminal mischief-71038-19). Howell stated both vehicles left the scene shortly after and he remained on scene and contacted the police.

Also on scene was a witness to the scene who was identified as Donald Salafia. Salafia stated he observed the motor vehicle accident that occurred on Route 88. Salafia stated the driver of the Jeep went to pass the Driver of the F-150 across double yellow while heading East on Route 88 and physically hit and forced F-150 off the road, causing damage to the F-150. Then the two drivers of the Jeeps got out of their vehicles and starting cursing and threatening driver of F-150. Then they punched mirror and broke of F-150. Also when jeep hit and pushed F-150 off road they caused damage to driver side front quarter panel, bumper and driver front rim of F-150.

Based on my observations and statements made on scene I determined the driver of V#1 (Camarato) to be at fault for the motor vehicle crash.

Camarato was issued summons that were sent in the mail. Summons #T-163507 for reckless driving and summons #T-163508 for leaving the scene of an accident.

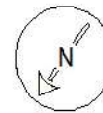
