145. Crash Description/Narrative

Vehicle 1 and 2 were both traveling westbound on Rt 88 near Jack Martin Blvd. Vehicle 2 was stopped at the red traffic signal. Vehicle 1 then collided with the rear of Vehicle 2.

The driver of vehicle 1 advised she was traveling westbound on Rt 88 near Jack Martin Blvd. Driver 1 advised she saw vehicle 2 stopped, however her tires began sliding on the wet roadway.

The driver of vehicle 2 advised he was traveling westbound on Rt 88 and stopped at the red traffic signal. Driver 2 advised he was then struck from the rear by vehicle 1.

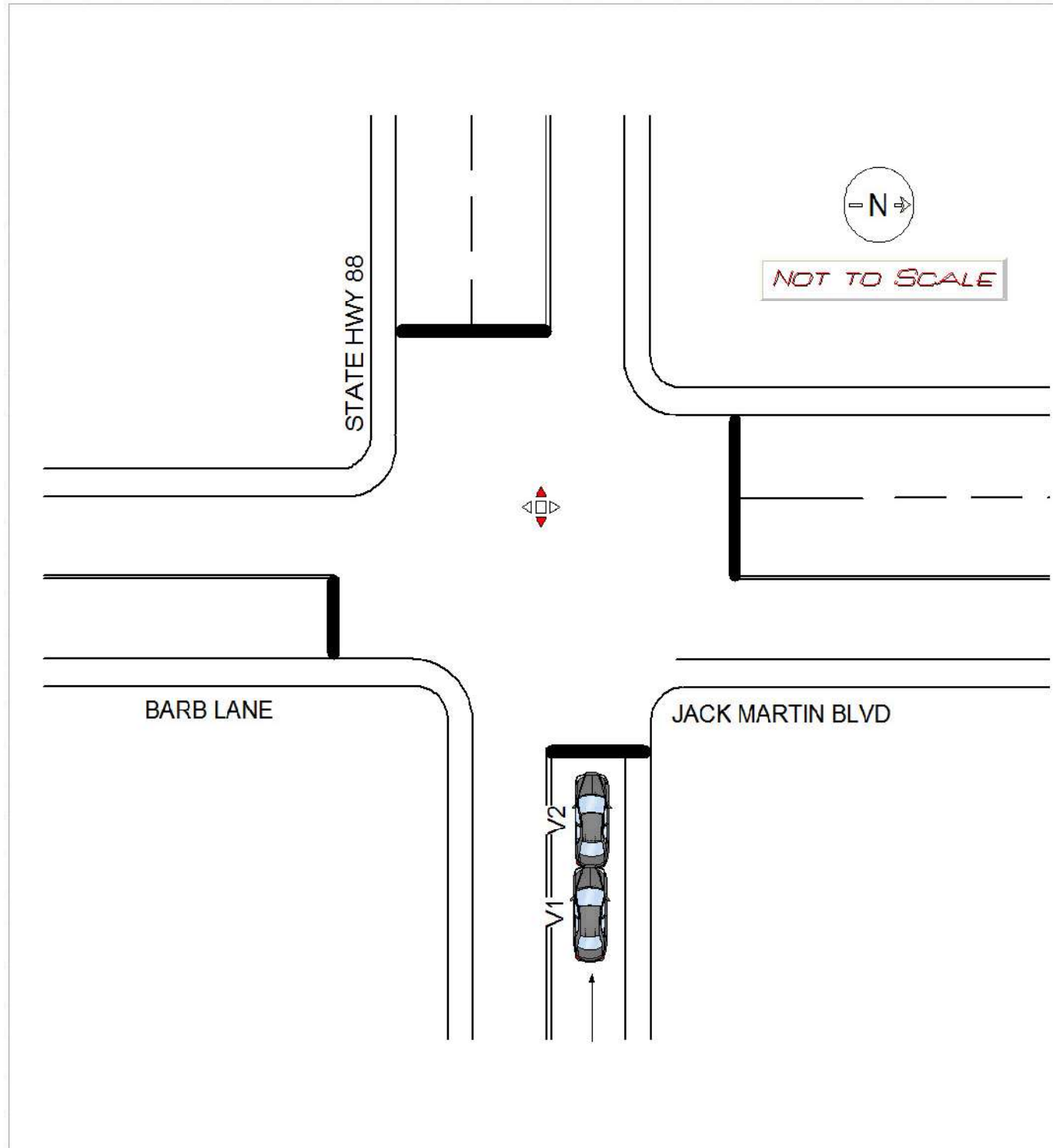
