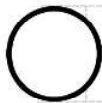

145. Crash Description/Narrative

Vehicle 2 was in the parking lot of 2085 Rt. 88 awaiting the turn onto Rt. 88 westbound. Vehicle 1 was parked in the marked parking space on the property of 2085 Rt. 88.

Vehicle 1 attempted to back out of the marked parking space. Vehicle 1 struck Vehicle 2 which was stopped in traffic awaiting the turn behind Vehicle 1.

Driver 1 stated she did not observe Vehicle 2 waiting at the exit of the parking lot when she struck Vehicle 2.

Driver 2 stated she was waiting to make the left turn onto Rt. 88 when Vehicle 1 struck the rear of her vehicle.

Both vehicles were moved prior to my arrival.

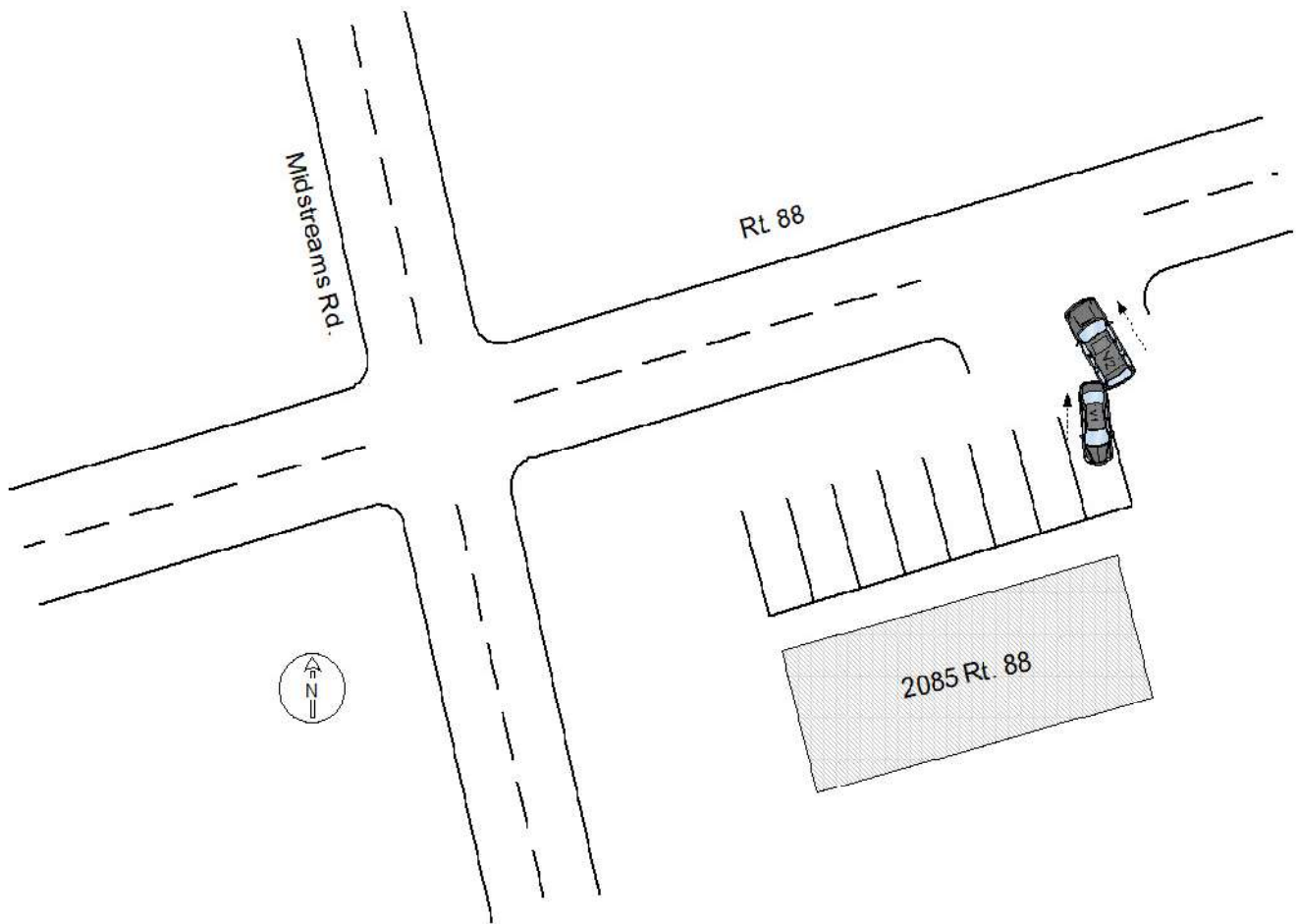
