145. Crash Description/Narrative

A motor vehicle crash occurred on Adams Drive approximately 25 feet north of the intersection to Route 88.

Driver of Vehicle #1 advised he was turning left onto Adams Drive from National Fuel (2064 Route 88). Driver #1 advised he didn't observe any vehicles while turning left onto Adams Drive. Driver #1 advised while turning, he was struck by Vehicle #2.

There was damage to the front passenger fender of Vehicle #1.

Driver of Vehicle #2 advised she was traveling south on Adams Drive towards Route 88. Driver #2 advised Vehicle #1 pulled out of the gas station parking lot, she honked her horn but it was too late and Vehicle #1 struck her vehicle.

There was moderate damage to the front drivers side door of Vehicle #2.

There were no reported injuries while on scene.

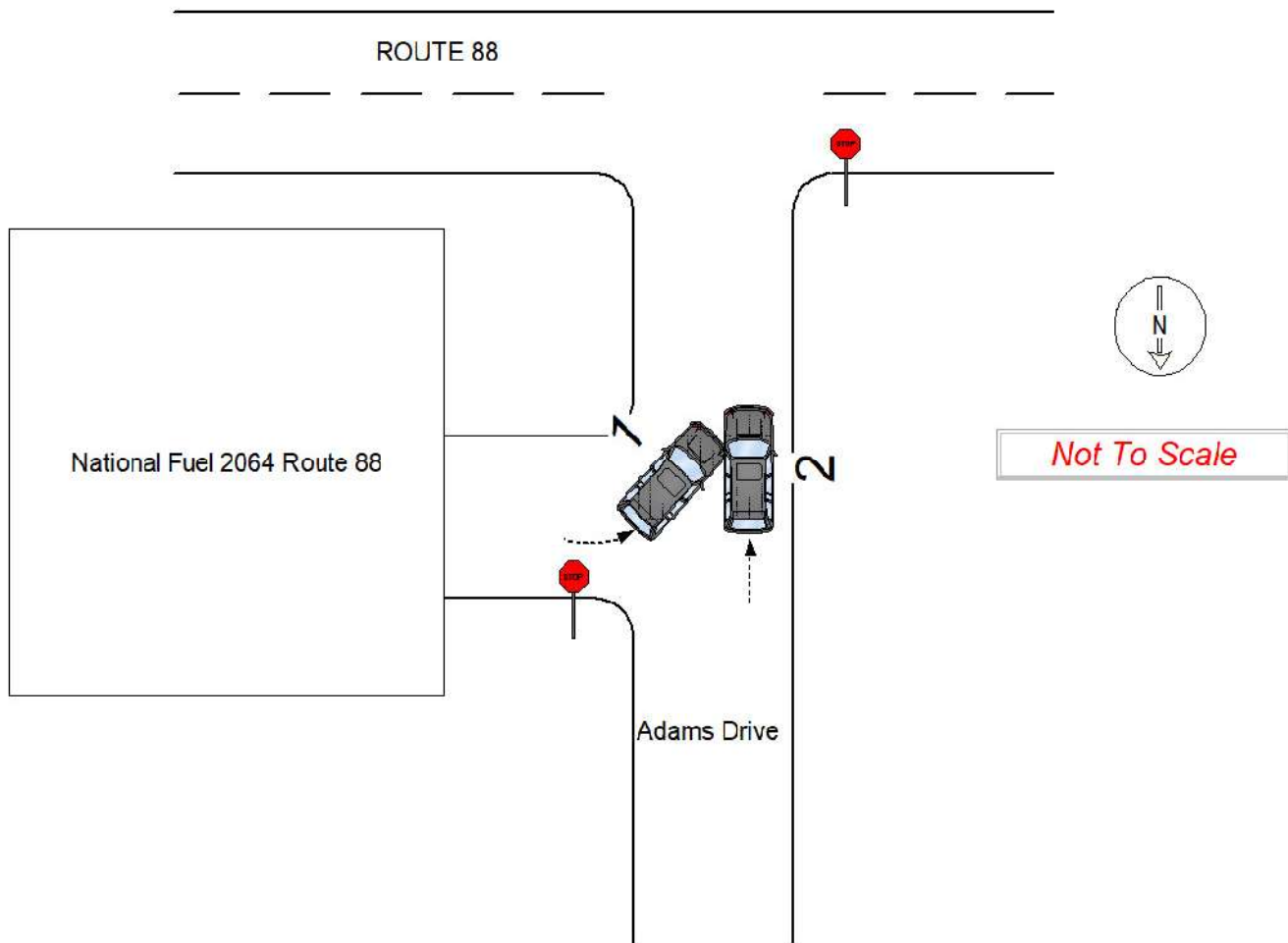
