145. Crash Description/Narrative

The driver of vehicle #2 stated he was traveling west on Rt. 88.. just east of Old Squan Rd.. stopped in traffic. He stated that while he was stopped, vehicle #1 struck him from behind.

The driver of vehicle #1 stated he was directly behind vehicle #2. He stated that he did not observe vehicle #2 directly stopped in front of him. He advised that he turned his head to look to the left and as a result he struck the rear of vehicle #2.

Moderate damage to vehicle #2. Minor damage to vehicle #1. No injuries reported.

Based on both of the driver's statements as well as observing the damage to both vehicles, it is my determination that vehicle #1 caused the crash by driver inattention as well as following too closely.

The driver of vehicle #1 received a summons for careless driving, 39:4-97, on summons # E01416.

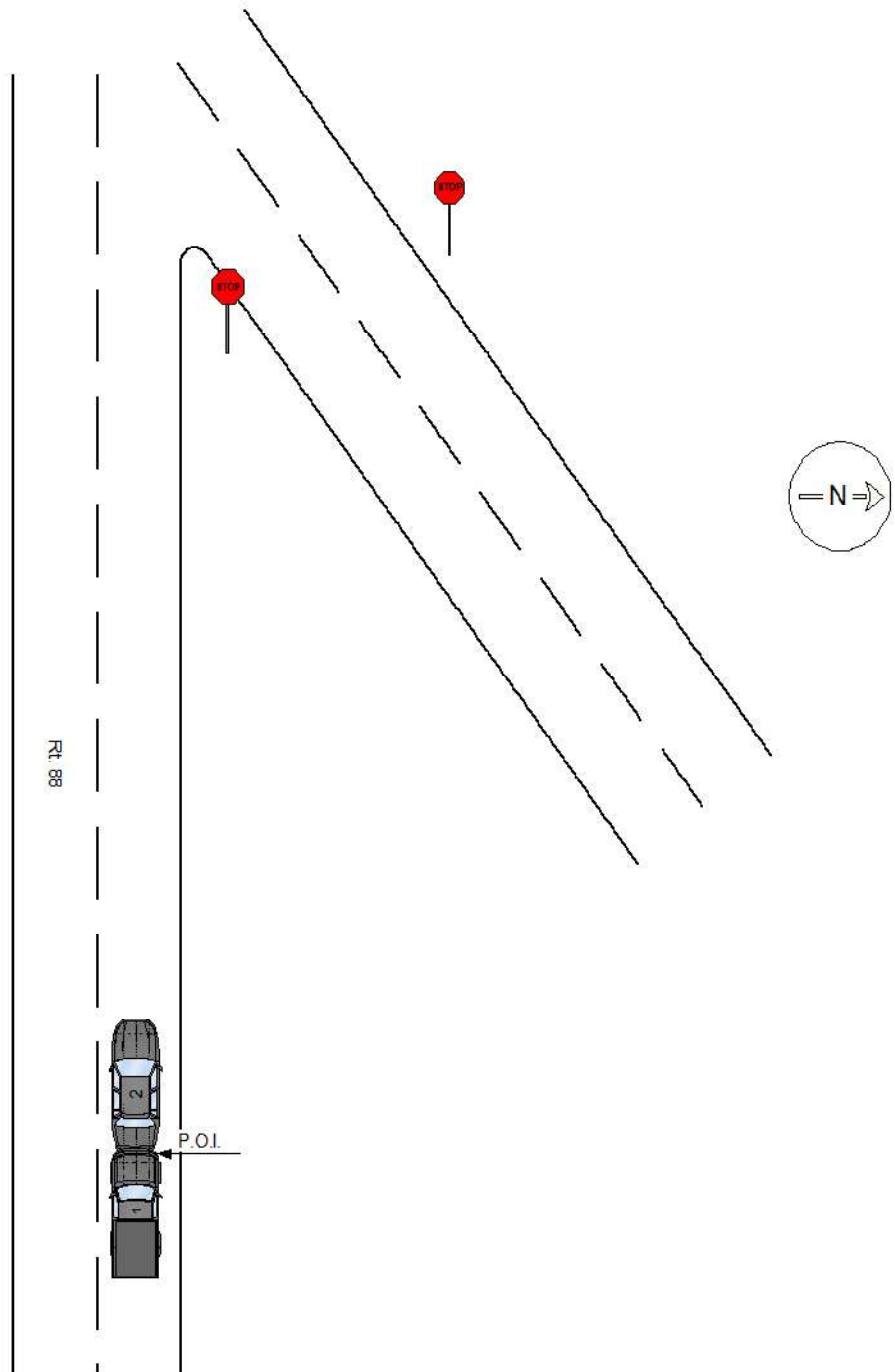
