145. Crash Description/Narrative

Crash investigation revealed V1 was traveling westbound through the intersection of Rt 88 and Midstreams Place. V1 was faced northbound, stopped at a stop sign on Midstreams Place and began to turn onto Rt 88 westbound. While making the turn onto Rt 88 westbound, V1 struck the driver's side door of V2 with the right lower bumper of V1.

Driver 1 advised she was at a stop sign behind a utility truck on Midstreams Place with the intent to turn westbound onto Rt 88. Driver 1 advised after the utility truck turned right (eastbound) onto Rt 88 she looked both ways and proceeded to make the left (westbound) on Rt 88. Driver 1 explained as she was making the left turn the right front of her vehicle collided with the driver's side door of V2. Driver 1 advised she never saw V2 when she checked traffic and believes the utility truck obstructed her view of V2. Driver 1 stated she was able to apply brakes but could not stop in time.

Driver 2 advised he was traveling westbound on Rt 88 when he felt V1 collide with his driver's side door. Driver 2 did state he also observed the utility check make a right (eastbound) onto Rt 88 and immediately after is when his vehicle was struck.

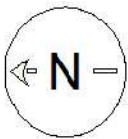

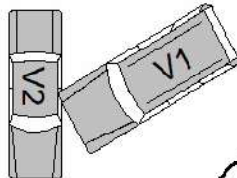
