145. Crash Description/Narrative

Vehicle #1 was improperly attempting to pass stopped Vehicle #2 at the exit to the Laurel Square Plaza (1930 Rt 88) onto Rt 88 west bound. As Vehicle #1 was passing Vehicle #2, Vehicle #2 rolled backwards and crashed into Vehicle #1.

The driver of Vehicle #1 stated that he was sitting behind Vehicle #2 (Tandem dump truck) at the exit for an inordinate amount of time, waiting to make the right turn onto Rt 88 west. He added that he utilized the horn of his vehicle numerous times in an attempted to notify the driver of Vehicle #2 of his presence, to no avail. The driver of Vehicle #1 explained that he then tried to pass Vehicle #2 on it's left in the exit and that as he was doing so, Vehicle #2 started to roll backwards and the crash occurred.

The driver of Vehicle #1 took photos of Vehicle #2's Texas temp tag (06661Z7) and was able to get a picture of the company name (KAL Transportation out of Bloomfield NJ). He added that the Hispanic male driver of Vehicle #2 did stop and speak to him but did not stay on scene after seeing no damage to his vehicle.

The driver of Vehicle #2 eventually returned to the scene and stated that he was waiting for oncoming traffic at the exit when Vehicle #1 tried to go around him. He added that his vehicle was stopped when Vehicle #1 sideswiped the rear of his truck. He did not have the vehicle's insurance card in the truck. After 10 days of trying to get this information from the truck owner (KAL Transportation/ Caroline Silva 973-489-4789) an
