145. Crash Description/Narrative

On 4/19/21 at 1545 hours I was dispatched to the area of Rt 88 and Midstreams Rd in reference to a motor vehicle accident. Upon arrival I observed both vehicles had moved in to a nearby parking lot.

The driver of vehicle 1 advised he was attempting to exit the parking lot of Wine World and turn left on to Midstreams Rd. Vehicle 2 was blocking the road while dropping off a dumpster and the business across the street. The driver of vehicle 1 attempted to get around vehicle 2, but failed to do so and crashed in to the front bumper of vehicle 2.

The Driver of vehicle 2 advised he had arrived at Joes Towing and Auto to deliver a dumpster on their property. He backed in to the property as far as he could, but was blocking most of Midstreams Rd in both directions. He put the truck in park, had a person direct traffic on Midstreams Rd and began dropping the dumpster. While doing this, vehicle 1 attempted to exit the parking directly across from him. Vehicle 1 tried to turn left on to Midstreams Rd, but did not have enough space and it crashed in to vehicle 2.

Investigation at the scene revealed vehicle 1 to be at fault. Vehicle 2 arrived at Joes Towing and Auto to

deliver a dumpster and had to temporarily set up in the roadway to do so. He parked vehicle 2, had a spotter go in the roadway, and started to deliver the dumpster. While vehicle 2 was actively dropping the dumpster, vehicle 1 approached from the parking lot directly across from him. Vehicle 1 attempted to turn left on to Midstreams Rd, but it did not have enough room to successfully clear vehicle 2. The right side of vehicle 1 crashed in to the front bumper of vehicle 2. Vehicle 1 sustained moderate damage while vehicle 2 had minor damage. No injuries were reported at this time and both vehicles were driven away from the scene.

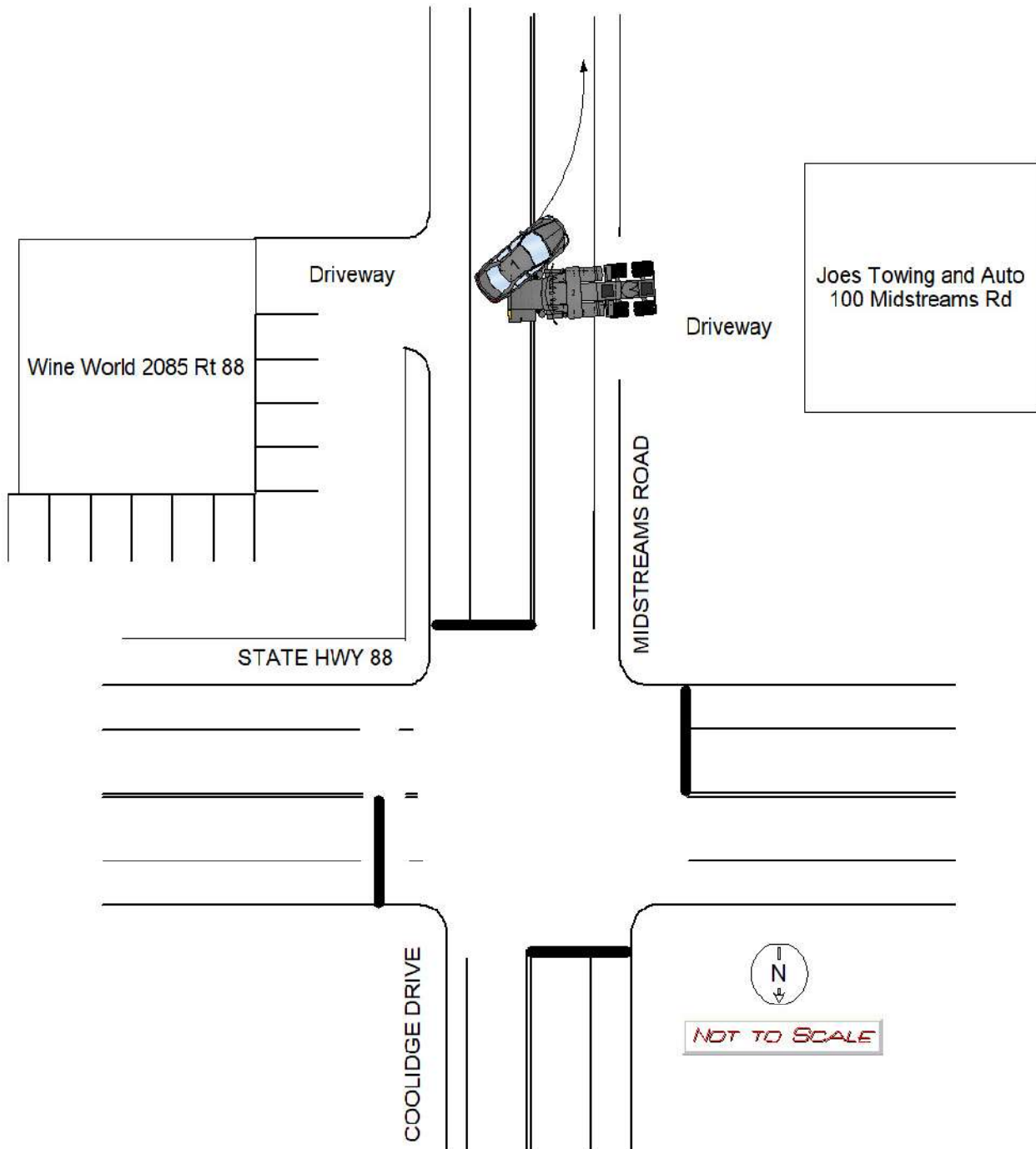
