145. Crash Description/Narrative

My investigation reveled the following: Vehicle 1 and vehicle 2 were stopped in traffic on RT 88 heading east bound just out front of the Dim Sum restaurant. The driver of vehicle 1 became distracted with his child in the back seat. While distracted, driver 1 took his foot off the brake making the vehicle begin to roll. With the vehicle rolling and the driver distracted vehicle 1 contacted the back bumper of vehicle 2 with its front bumper. Both vehicles received minor damage.

Driver 1 stated he was distracted with his child and did not realize his vehicle was moving. Vehicle 1 contacted the rear bumper of vehicle 2 causing minor damage.

Driver 2 stated he was stopped in traffic on RT 88 when vehicle 1 contacted his rear bumper.

There were no injures to report at the time and both vehicles were able to be driven away. Our body worn cameras were activated during our time on scene. I find vehicle 1 at fault based on the events reported to me while on scene and both parties agreeing on what happened.

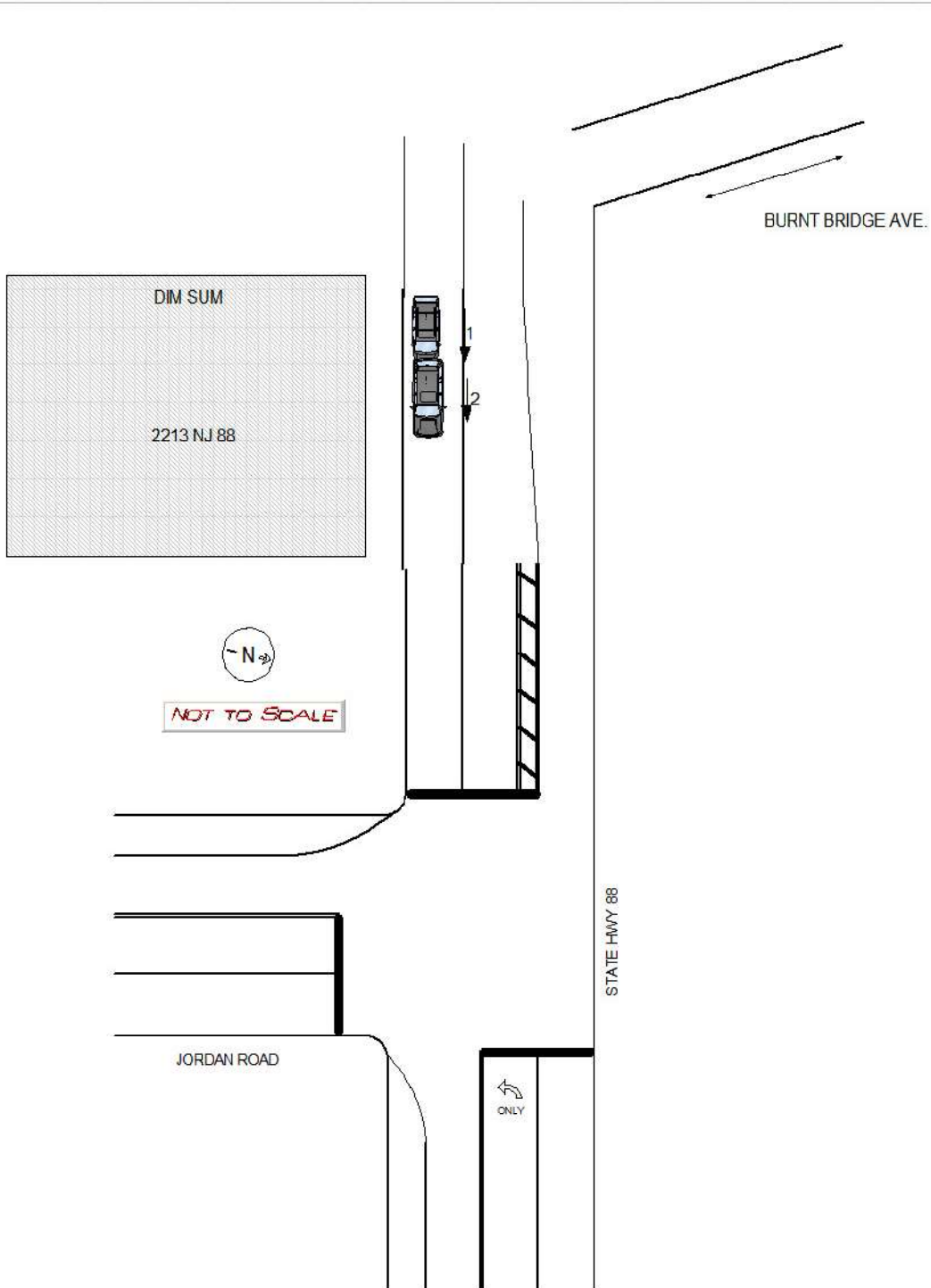
