145. Crash Description/Narrative

Crash Investigation revealed that vehicle 2 was stopped at a red light in the middle lane, eastbound on Route 70

when the front of Vehicle 1 hit the rear of vehicle 2.

Driver of vehicle 1 stated she was positioned behind Vehicle 2 in the middle lane of Route 70 (East), stopped at the red traffic light. Driver of vehicle 1 further stated that Vehicle 2 began to move forward and then suddenly stopped. Driver of vehicle 1 stated she was not able to stop and the front of her vehicle hit the rear of vehicle 2.

Driver of vehicle 2 stated that she was stopped at the red light in the middle lane of Route 70 (East) when she felt the impact of vehicle 1 hitting the rear of her vehicle.

Driver of vehicle 1 and driver of vehicle 2 sustained no injuries.

On scene, I observed no damage to the front of vehicle 1 and I observed minor damage to the rear of vehicle 2.

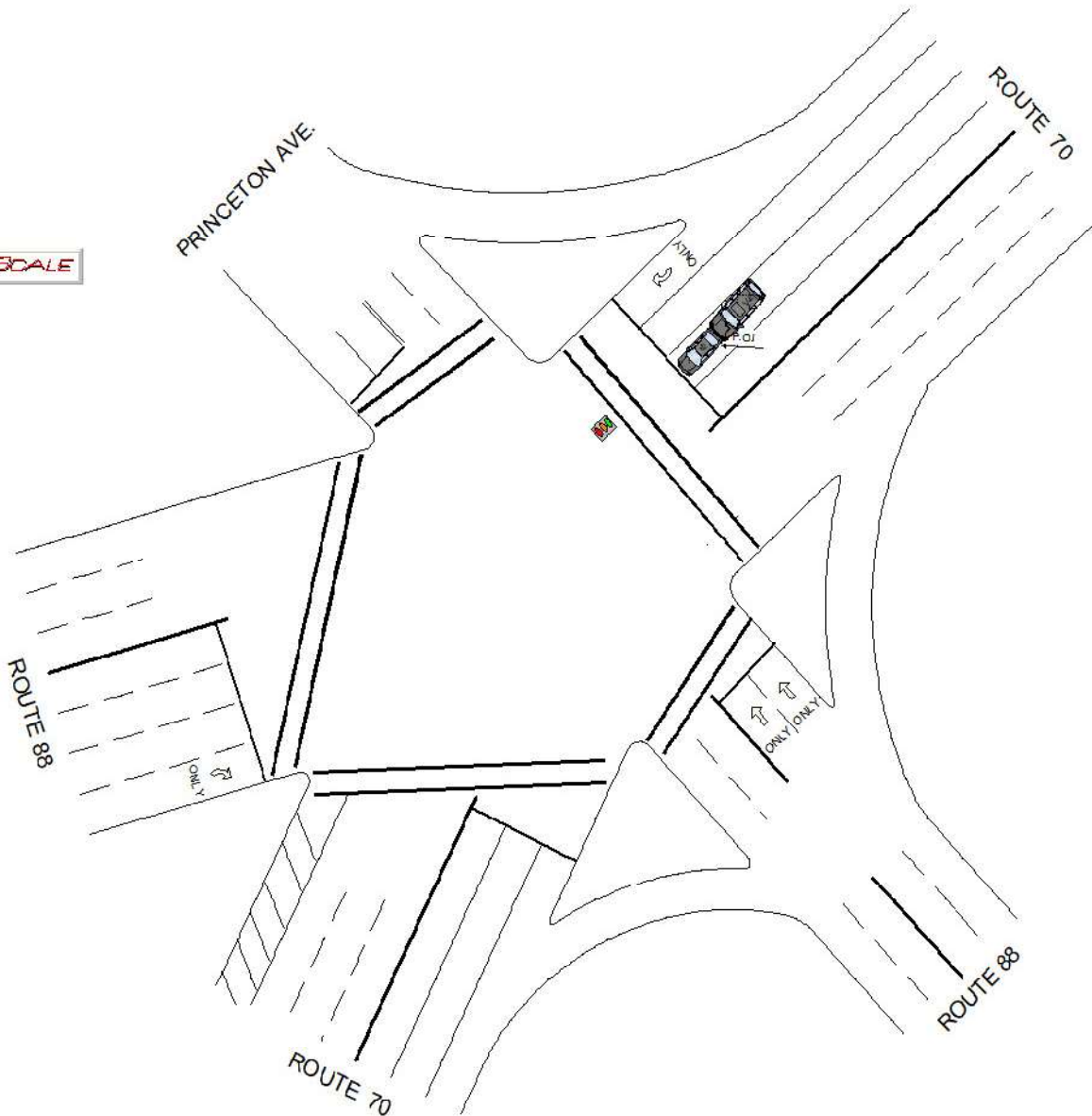
