145. Crash Description/Narrative

Vehicle 1 was traveling east on Route 88 approximately 200 feet west of Jordan Road. Vehicle 2 was stopped in traffic facing east. Vehicle 1 began to drive and did not observe Vehicle 2 stopped in traffic rear ending Vehicle 2.

In speaking with the driver of Vehicle 1, she stated that she was traveling east on Route 88 in stop and go traffic with Vehicle 2 directly in front of her. She stated the light had just turned green and Vehicle 2 had not started to go. The driver of Vehicle 1 stated she attempted to stop but due to the rain, Vehicle 1 began to skid and was not able to stop in time crashing into the rear of Vehicle 2.

In speaking with the driver of Vehicle 2, she stated she was stopped in traffic on Route 88 facing east. The light had just turned green and before being able to start driving, Vehicle 1 crashed in the rear of Vehicle 2.

Vehicle 1 had moderate damage to the front bumper while Vehicle 2 had minor damage to the rear bumper. Based on the statements made and the facts of my investigation, the driver of Vehicle 1 is at fault for the accident.

Driver 1 was issued a summons for 39:4-97.

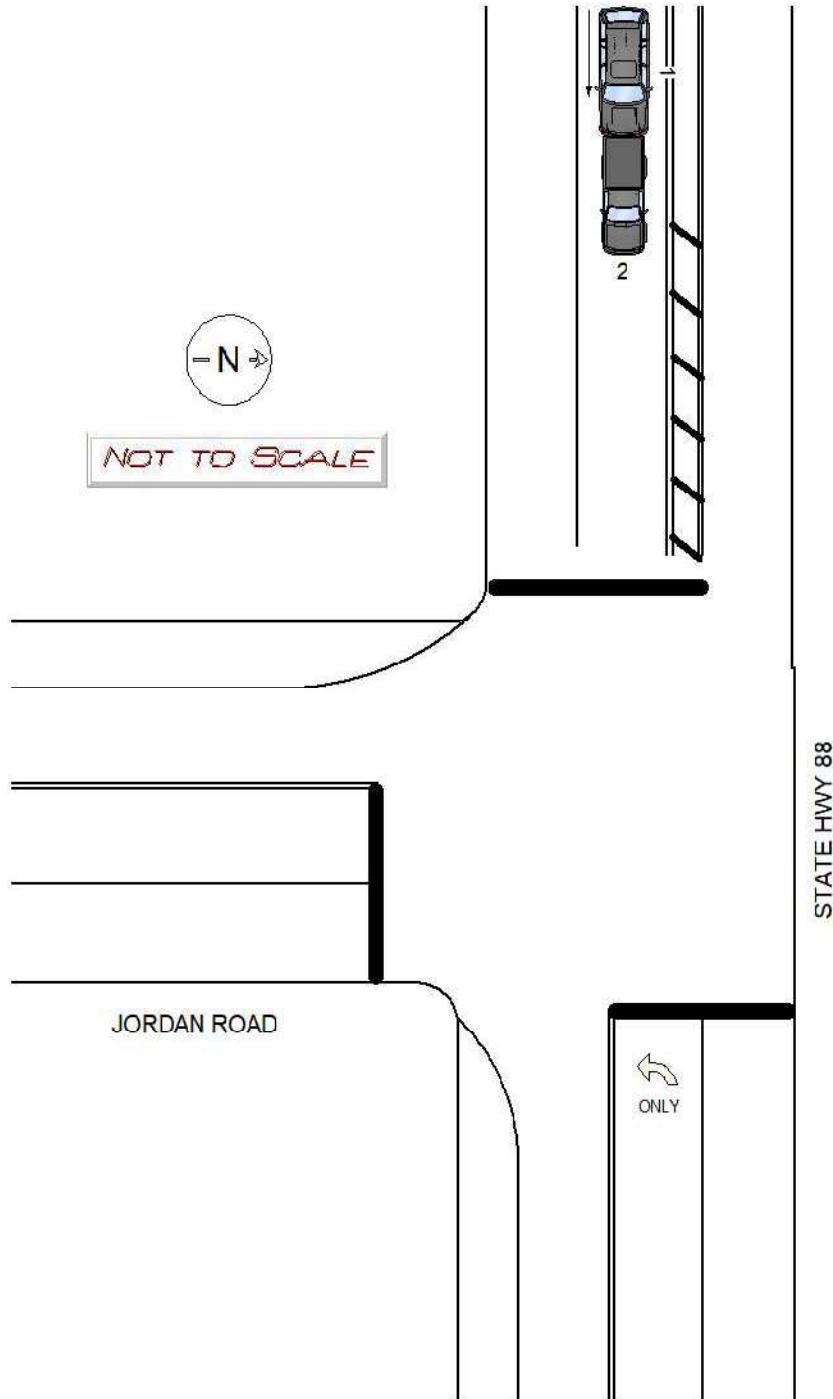
