145. Crash Description/Narrative

Vehicle 1 and 2 were both traveling northbound on Olden St. Vehicle 2 was stopped due to traffic when vehicle 1 collided with the rear of vehicle 2.

The driver of vehicle 1 advised he was on Olden St. behind vehicle 2 in stop and go traffic. Driver 1 advised vehicle 2 moved up and he did as well. Driver 1 observed vehicle 2 stop and he attempted to stop as well. Driver 1 advised he accidentally hit the gas pedal instead of the brake causing him to collided with vehicle 2.

The driver of vehicle 2 advised she was traveling northbound on Olden St in stop and go traffic. Driver 2 advised she was stopped in traffic when vehicle 1 collided with the rear of her vehicle.

The driver of vehicle 1 is found to be at fault for the collision.

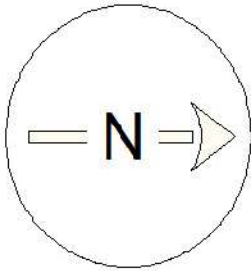

Motor Vehicle Crash Diagram

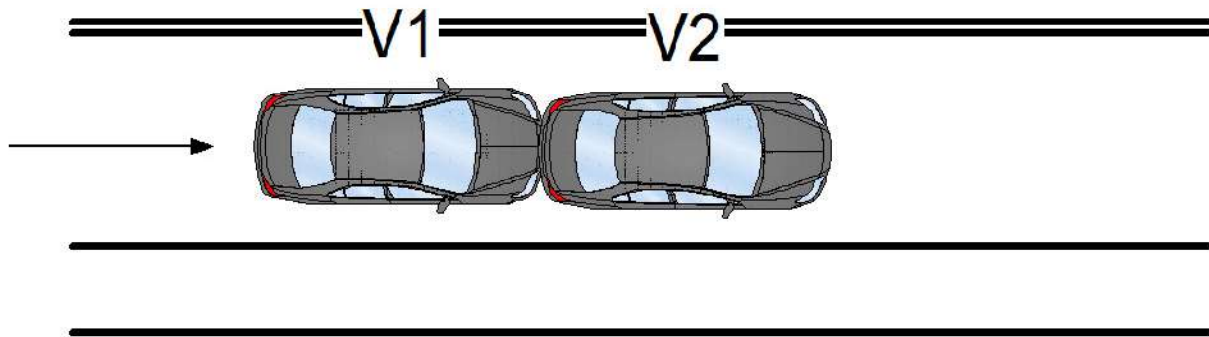
