Vehicle 2 stopped in traffic, Route 88 westbound, approaching Kenneth Place. Vehicle 1 traveling westbound on Route 88 directly behind Vehicle 2.

Driver 2 stated they were in stop and go traffic. Driver 2 stated he came to a stop in traffic and was then struck from behind by Vehicle 1.

Driver 1 stated he first came to a stop at the exit of Laurel Square, 1930 Route 88. An unknown female driver trying to exit the parking lot became upset because he did not allow her to exit. As traffic started to move, the unknown vehicle pulled out behind him. Driver 1 checked his rear view mirror and could see the unknown female yelling and making hand gestures towards him, distracting him. Driver 1 stated while he was distracted, he struck the rear of Vehicle 2 with the front end of his vehicle.

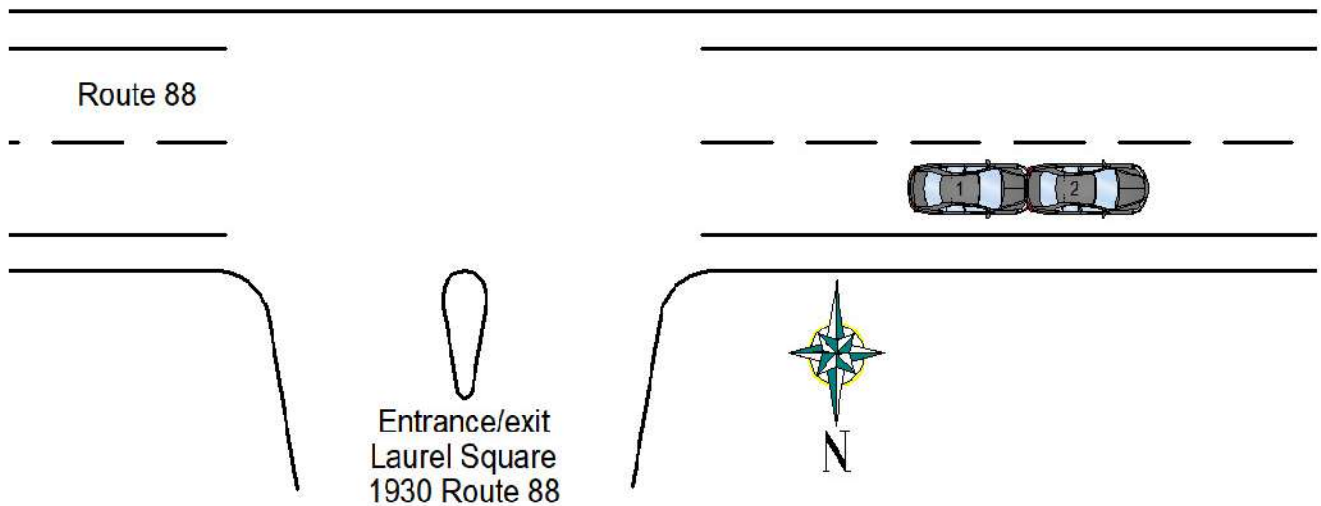
Driver 1 was found to be at fault for failing to observe traffic stopped in front of him.
