145. Crash Description/Narrative

Vehicle 1 was traveling north bound on Jordan Road and was approaching the intersection with Waters Edge Court. A deer ran onto the road from the woods on the eastern side of Jordan Road and leapt in front of Vehicle 1. The front driver side corner of Vehicle 1 struck the deer on the rear. The deer then took off into the neighborhood located on Duchess Lane.

While on scene, there were no reported injuries.

Driver 1 stated she was traveling on Jordan Road so that she can get onto Route 88. Driver 1 said she observed the deer suddenly run in front of her vehicle. Driver 1 advised she could not stop in time and she struck the back legs of the deer. Driver 1 further advised the deer got back up and ran into the neighborhood without issue.

Through my investigation, I find the actions of the deer to be the cause of the accident.

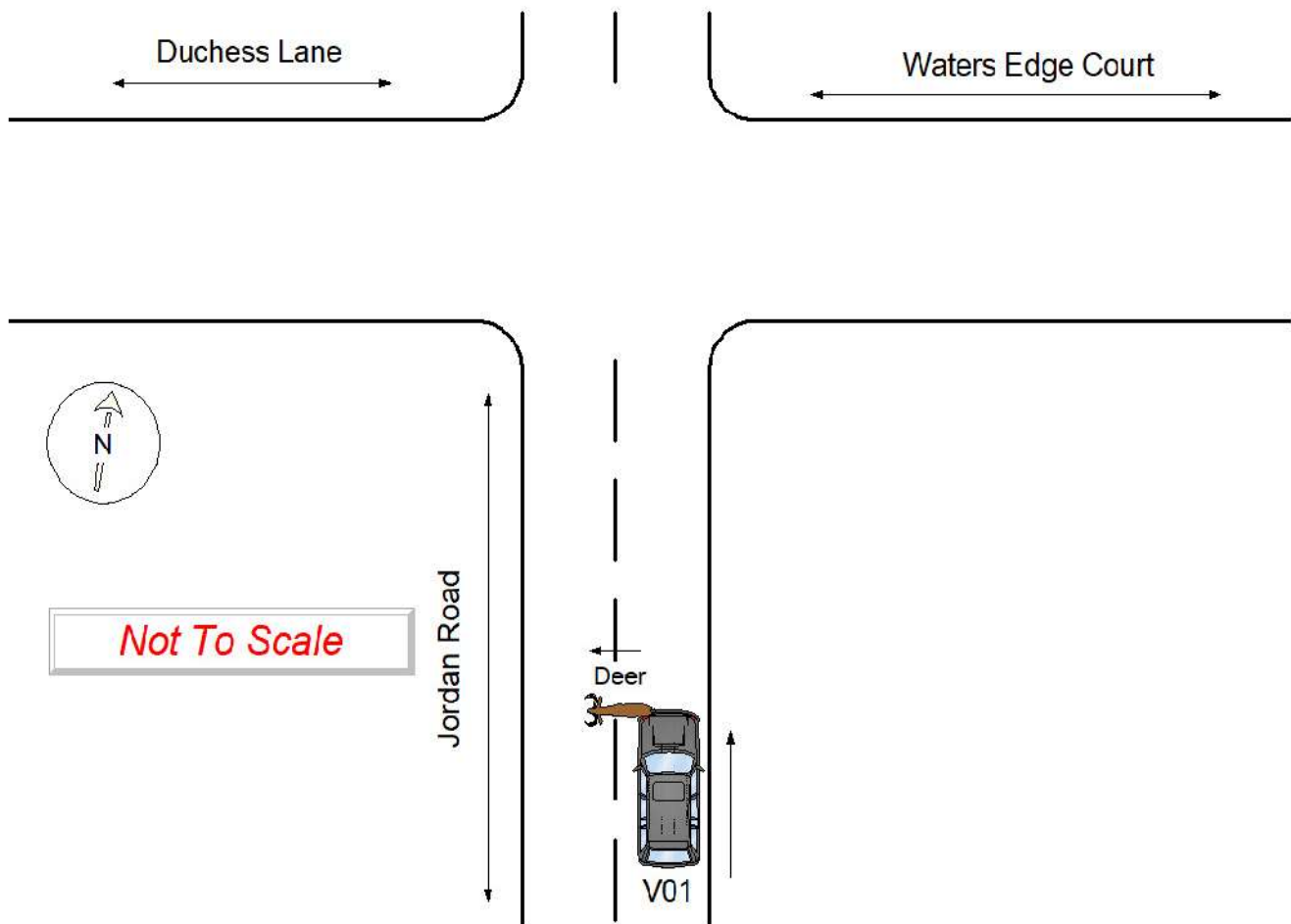
