145. Crash Description/Narrative

Vehicle 2 was traveling east on Rt. 88 approaching the intersection of Brentwood Avenue. Vehicle 1 was traveling behind vehicle 2. Vehicle 2 was slowing down in order to make a left turn from Rt. 88 onto Brentwood Avenue. Vehicle 2 slowed to an almost stop when vehicle 1 struck vehicle 2. Vehicle 1 struck vehicle 2 with vehicle 1's left lower front portion causing moderate/functional damage to vehicle 2 right lower rear and disabling damage to vehicle 1.

Driver 2 stated she was traveling east on Rt. 88 slowing down to make a left turn onto Brentwood Avenue. As she was stopped, waiting for the west lane of travel to be clear for her to turn over them, vehicle 1 struck the rear of her vehicle.

Driver 1 stated he was travelling west on Rt. 88. He stated as he was driving he was looking down inside of his vehicle. When he looked up at the roadway ahead he struck the rear of vehicle 2.

Brick Police EMS along with Toms River EMS arrived on scene and transported all occupants of both vehicle 1 and vehicle 2 to Ocean Medical Center. Vehicle 2 was driven from the scene while vehicle 1 was towed due to it

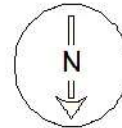

Motor Vehicle Crash Diagram

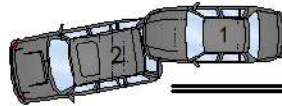
