145. Crash Description/Narrative

Vehicle 1 was traveling east on Route 88 approaching the intersection of Coolidge Drive. Vehicle 2 was traveling south on Coolidge Drive approaching the intersection of Route 88. The front lower right of Vehicle 1 struck the rear lower right of Vehicle 2 while both vehicles were in the intersection. The driver of Vehicle 1 left the scene of the crash and made no contact with police.

The driver of Vehicle 2 stated that she was stopped at the red light for the intersection of Coolidge Drive and Route 88. She observed the traffic signal turn green when she began accelerating through the intersection and observed Vehicle 1 approaching from her right side. She then swerved her vehicle to the left to try and avoid being struck by Vehicle 1, and was unsuccessful. She then contacted Brick Police to report the crash and observed Vehicle 1 leave the scene.

I was able to view footage of the crash from the BP gas station (2081 NJ-88). I observed Vehicle 1 drive through the red light and enter the intersection, striking Vehicle 2 which was already in the intersection.

I was able to contact the driver of Vehicle 1 after visiting her residence and speaking with her mother who called

her. I then met the driver of Vehicle 1 in the Sundaes parking lot (3217 NJ-88) to collect her information and speak with her about the incident. The driver of Vehicle 1 stated that she had a green light at the intersection and Vehicle 2 drove through the intersection in front of her. She then swerved her vehicle to the left to avoid hitting Vehicle 2 unsuccessfully. After hitting Vehicle 2, she drove her vehicle to the Sundaes parking lot (3217 NJ-88) where she observed damage to her vehicle. She then stated that she did not report the incident because the driver of Vehicle 2 sped away after the crash.

After speaking with both drivers and conducting my investigation, I determined the driver of Vehicle 1 to be at fault for the crash. The driver of Vehicle 1 was issued three summonses in reference to the crash.

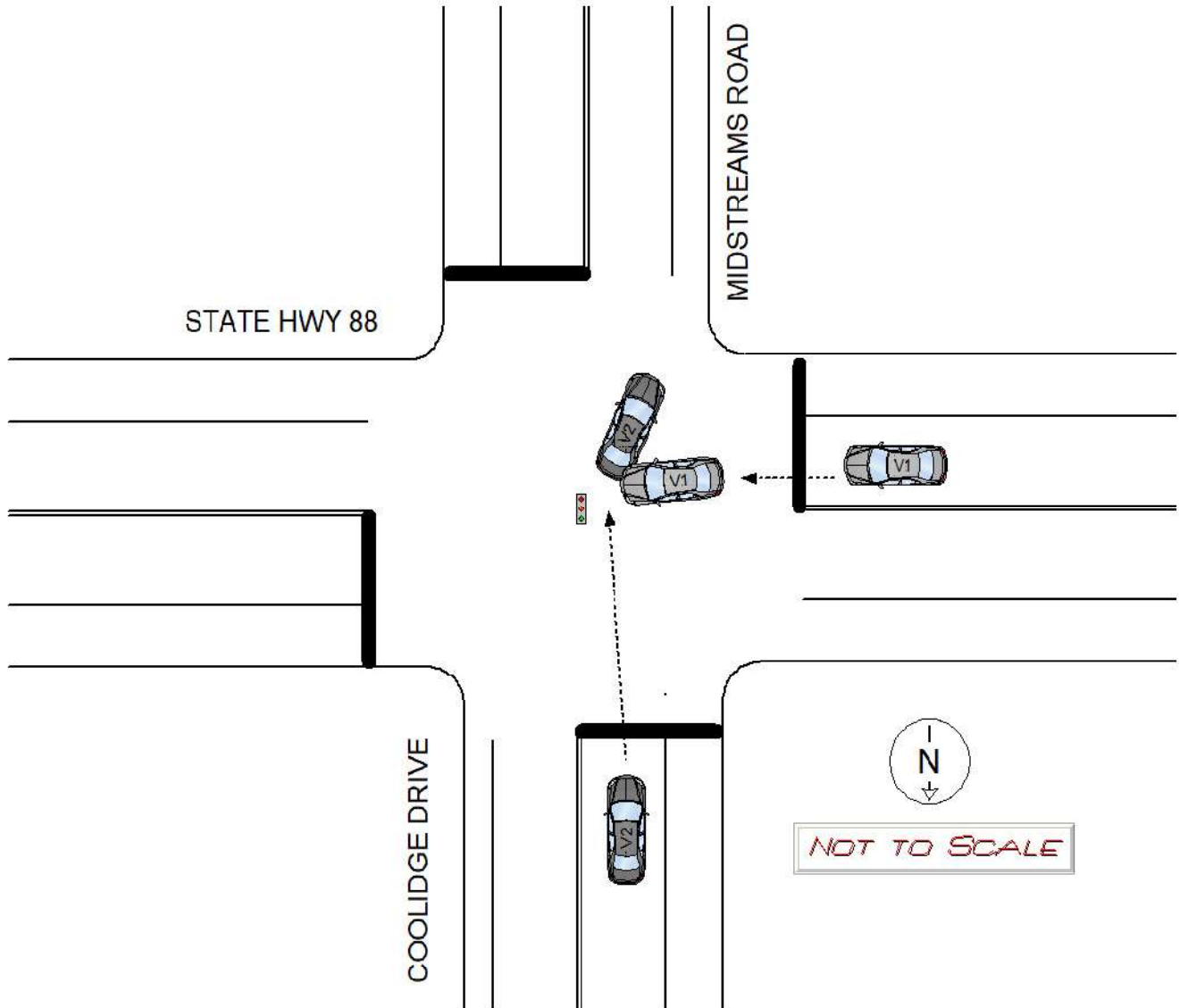
