145. Crash Description/Narrative

Upon arrival both vehicles were located on scene.

The driver of vehicle #2 stated she was sitting in her parked vehicle in front of the store. She stated vehicle #1 was parked in the parking stall to the left of her vehicle. When vehicle #1 started to back out of the parking spot, the front right bumper/ fender side swiped the left middle and mirror of vehicle #2 causing moderate damage to vehicle #2.

The driver of vehicle #1 admitted to backing his vehicle out of the parking stall and while doing so he did not realize vehicle #2 was parked to the right of his vehicle. Driver #1 said when he cut the wheel to the left, the front right bumper/ fender collided into the left middle of vehicle #2. Vehicle #1 made minor damage to the impact area.

On scene investigation determined driver #1 to be at fault for unsafe backing and admission to being at fault.

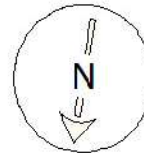

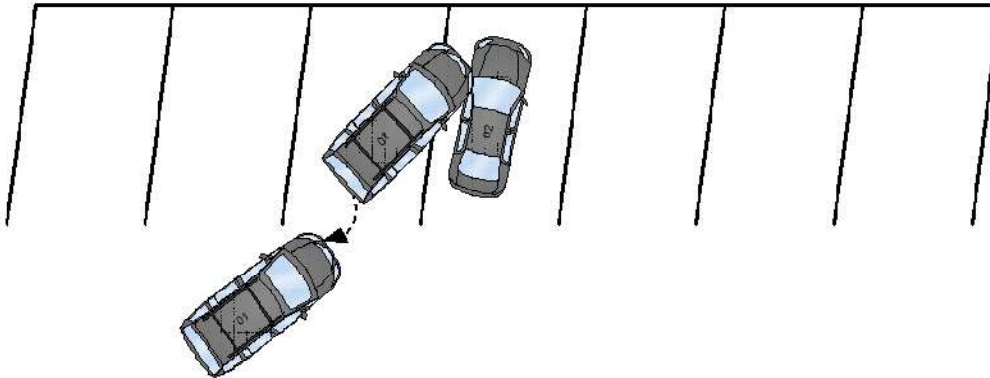
144 Crash Diagram (NOT TO SCALE)
