145. Crash Description/Narrative

On scene investigation revealed that both vehicle 1 and vehicle 2 were traveling east on Rt 88 just past Adams Drive. Vehicle 1 struck vehicle 2 from behind, where vehicle 1 then fled the scene. Driver of vehicle 2 was able to ascertain vehicle 1's registration as "L42MMS". Driver 2 provided the following statement:

Driver 2 stated she was traveling east on Rt 88 just after Adams Drive. Vehicle 1 had struck her in the rear bumper. Driver 2 stated the vehicle was a silver sedan being operated by a female. Vehicle 1 fled the scene continuing east on Rt 88 into Point Pleasant. Vehicle 2 had minor rear end damage consisting of dents, scratches and paint transfer. Vehicle 2 was driven from the scene. Driver 2 did not report any injuries on scene.

Upon further investigation an NCIC check of the provided registration indicated the silver sedan was a silver Ford Focus that was registered to a female out of Point Pleasant Beach. The information was forwarded to the Point Pleasant Beach Police Department where I requested they send an officer out to the address to obtain info from the driver. Eventually officers made contact with the registered owner who stated she was driving the vehicle all day but denied being in an accident. Officers did however observe fresh minor damage to the front bumper of the Ford Focus that was parked on scene.

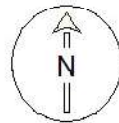
