145. Crash Description/Narrative

Driver #1 was traveling East on Rt 70 in the left lane. Driver #1 began to enter the right lane and lost control of her vehicle causing her to strike a light pole in the entrance of Laurel Square shopping Center.

Driver #1 stated she was traveling East on Rt 70. She stated she was attempting to enter the right lane and her brakes locked and she was unable to stop in time to make the right turn into Laurel Square. She stated she lost control of the vehicle and struck a concrete barrier connected to the light pole. There was no damage to the concrete light fixture.

My investigation revealed driver #1 was traveling in the left lane and lost control of her vehicle, which caused her to leave the roadway and strike a light pole. Driver #1 stated she was unable to brake which contributed to the crash. There were no other vehicles involved in the crash.

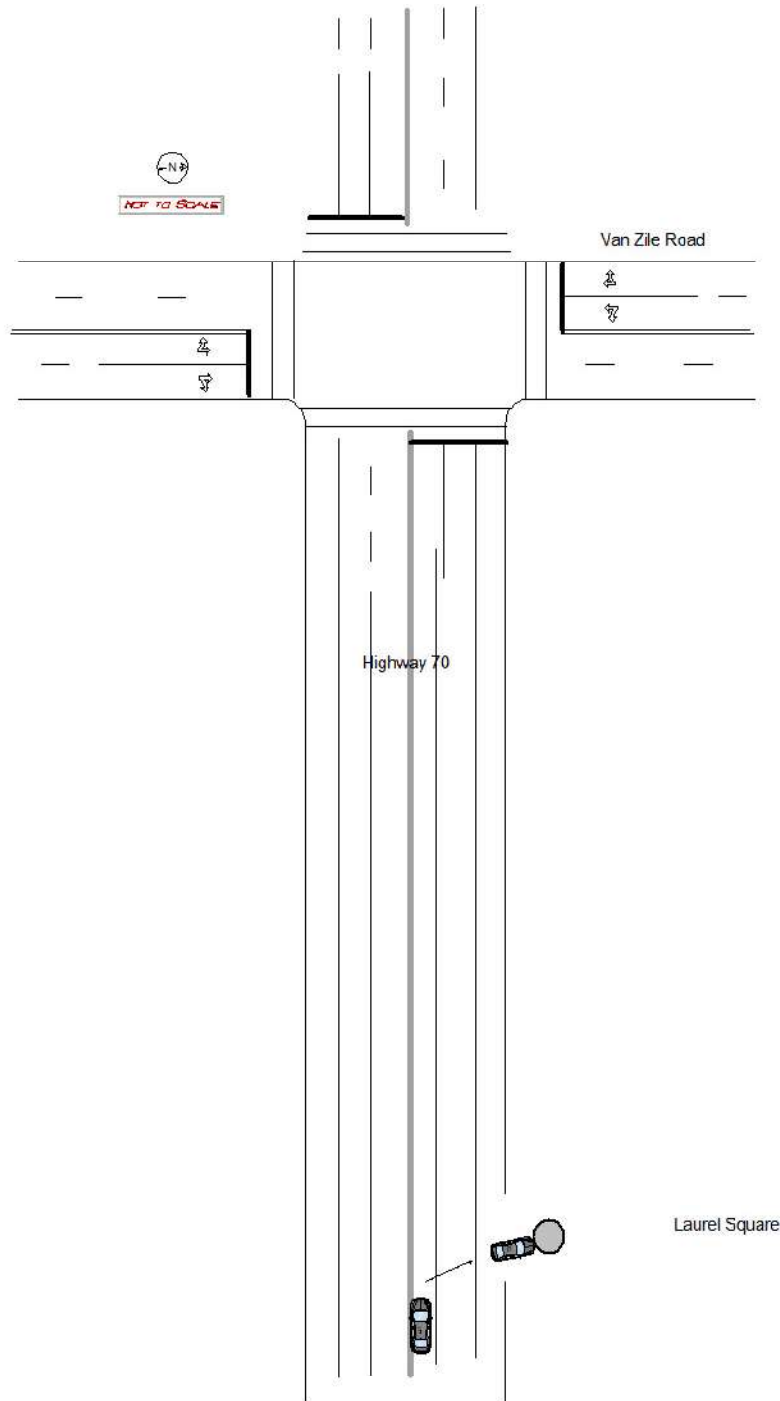
