145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 1 was parked at the 7-11 located at 2075 Route 88.

Vehicle 2 was attempting to park next to vehicle 1 at the 7-11. Vehicle 1 backed out of the parking space and

hit vehicle 2 on the passenger side fender, which caused minor damage.

I spoke to driver 1 at the scene: he stated he was backing out when he scraped the vehicle next to him.

I spoke to driver 2 at the scene. She stated she was pulling into the parking space and was hit by the vehicle attempting to back out.

Based on statements made, it was determined driver 1 was at fault.

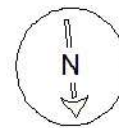
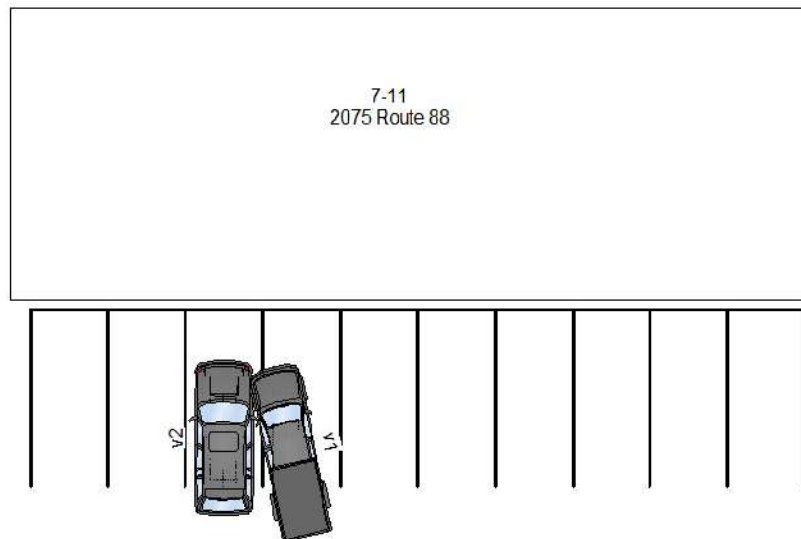
