**** Vehicle 01 is Self insured #5-87 with Ocean County Municipal Joint Insurance Fund.**

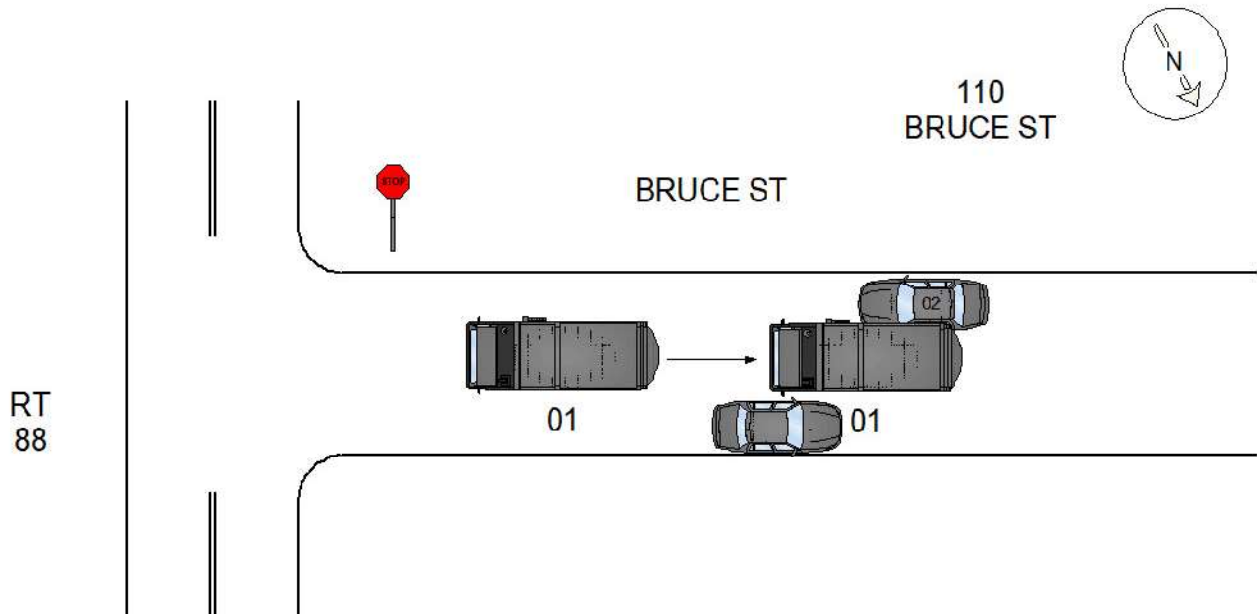
